

18. To promote organize and sustain all types of media channels, and networking for dissemination of knowledge an information, to enable human beings live life with dignity.
19. To impart training in all professional and vocational activities including languages.

And to do all such other lawful things as are incidental or conducive to the attainment of the above objects.

RULES AND REGULATIONS

These rule and regulation shall be called the Rule and Regulation of Confederation of "CHARAK HEALTH CARE & RURAL DEVELOPMENT TRUST" herein after referred to as TRUST.

The name of the TRUST shall be CHARAK HEALTH CARE & RURAL DEVELOPMENT TRUST.

AIMS AND OBJECTS: The Aims objects and functions of the CHARAK HEALTH CARE & RURAL DEVELOPMENT TRUST shall be he same as those contained in the Memorandum of the Association.

MEMBERSHIPS: All those persons/ institution who are keen for the promotion of Education Literature, Fine Arts, Science , Law, B.Ed, Medical, Paramedical, Nursing, Engineering, Technical, Management courses and other Social Welfare activities like health care providing may be the Member of the Trust ,

SETTLOR TRUSTEE: The settler Trustee shall be the permanent member of the board of Trustees and shall have the power to appoint the Arbitration committee consisting of 3 persons for any difference of opinion /disputes among the Board of Trustee over the functioning and interpretation of the Memorandum of Association and Rules and Regulations.

FONDER MEMBERS: Those members who have been responsible for the creation and brining up the TRUST initially and continue to remain valid member of the TRUST shall be the Founder Members. They shall be the members for their whole life. All such persons who have been instrumentals in the creation of this Trust and who have been designated as such by the first meeting of Board of Trustees shall be the Founder Member.

ASSOCIATE MEMBERS: Any person, having interest in promotion of education literature . Fine Art, Science, Law, B.ED, Medical, Paramedical, Nursing, Engineering, Management courses and other Social Welfare activities may be the Member of the Trust, who applies for Membership of the TRUST on the prescribed form along with the application fee of Rs.100/- and whose application is approved by the BOARD OF TRUSTEES for admission to the membership of the TRUST shall become an Associate Member provided he/she pays the annuals subscription of 500/= immediately on receipts of the intimation of his/her admission to the membership.

AFFILIATED MEMBER: The TRUST will have Affiliated Membership of autonomous units for the fulfillment of wider areas of Objects of the TRUST. Such members shall pay annual subscription of Rs. 5,000/- or any other amount which may be fixed by Board of Trustees formed under these Rules and as framed by the BOARD OF TRUSTEES of the TRUST from time to time.

INSTITUTIONAL MEMBERS: The BOARD OF TRUSTEES may in accordance with the provisions laid down in its behalf, may admit any Institution/Trust/Society, working in the field of education Literature, Fine Arts, Science, Law, B.Ed, Medical, Engineering, management courses and other social welfare activities similar to that of the TRUST as Institutional Member. Such members shall pay annual subscription of Rs. 5,000/- or any other amount which may be fixed by Board of Trustees formed under these Rules and as framed by the BOARD OF TRUSTEES of the TRUST from time to time.

LIFE MEMBERS: Members who wish to apply for Life Membership and whose application is approved by the BOARD OF TRUSTEES, can become Life Member of the TRUST after paying Rs. 25,000/-, in case of individual member and Rs. 50,000/- in case of institutional member, or more in lump sum. Once admitted as Life Member, such member will not be required to pay the Annual Subscription, and will continue to remain member unless resigned and/or removed under provision of these articles.

PATRON: The BOARD OF TRUSTEES may invite persons of eminence in public life, having contributed in the field of education Literature, Fine Arts, Science, Law, B.Ed, Medical, Paramedical, Nursing, Engineering Technical, Management course, health promotion and other social welfare activities to that, as Patrons of the TRUST on such terms and conditions as the Board of Trust may decide from time to time.

Mr. S.K. Singh shall be the permanent patron of the Trust.

ENROLLMENT AND CANCELLATION OF MEMBERSHIP

ENROLLMENT: All application for memberships of the TRUST shall be addressed to the general Secretary of the TRUST who after satisfying himself/ herself that the application is in order, shall place the same before the BOARD OF TRUSTEES for its consideration. The decision of the BOARD OF TRUSTEES regarding such application shall be final and cannot be questioned by the applicant.

CANCELLATION OF MEMBERSHIP: All categories of membership, shall cease and terminate if the membership fee payable for each year is not paid within 30 days of the expiry of the financial year and after a written notice is given to the member concerned, the BOARD OF TRUSTEES in its discretion may re-admit such member who is ready to pay all the arrears of the subscription together with re-admission fee of Rs. 2000/-
