

AMENDMENDED BYE-LAWS :

1. *Name of Society* : Ganpat Sahai Degree College Association
2. *Address* : Civil Lines, Sultanpur (U.P.)
3. *Area of Activity* : Whole state of Uttar Pradesh
4. The capital of the association shall be the donations and endowments made by the Founder of the College (Shri Ganpat Sahai, Advocate, Sultanpur) donations received from other donors and the patrons of the college, subscriptions received from the members of the public as also from the members of the Association and of the Managing Committee of the College, Grants-in-aid received from the University Grants Commission, the Government of U.P. and India, and the University of Dr. R.M.L.A.V.V., Faizabad, and the amounts received from the students of the college in the shape of fees etc.

Membership : There shall be only one class of members i.e. Life members of General Body of the society

Eligibility of Life Members : All the Indian Citizens are eligible to be the members of the society, who accept the Memorandum & Bye-laws of Society and paying membership fee Rs. 1,000.00 to Secretary cum Manager of the Society. After recommendation of Secretary cum Manager and approval of the 'Managing Committee'. The Secretary cum Manager will make him member of the Ganpat Sahai Degree College Association.

TO FORM A MANAGING COMMITTEE OF THE COLLEGE :

- (A) The Managing Committee shall consist of Sixteen members only elected by "General Body" of the Association and also teacher's representative and representative of class three employees as directed by first statues of the Dr.R.M.L.A.V.V., Faizabad and Directed by Government be member of the Managing Committee.

(C) *The tenure of the members of the Management Committee shall be as under :-* Management Committee Ganpat Sahai Degree College Association, Civil Lines, Sultanpur as well as Associated College : 5 years

(D) POWERS OF THE GENERAL BODY OF THE ASSOCIATION :

Powers, duties and scope of the College Association shall be :

(a) To Acquire funds and properties, to promote its object.

(b) To strive in any other way to further its cause.

(c) To elect : The President, Vice-President, Secretary-cum-Manager after Shri Om Prakash Pandey and Assistant Secretary, Treasurer, Auditor & other Members of the Managing Committee.

(d) To fill any vacancy occurring in the its office-bearers of members of the Managing Committee by electing from amongst its members for the remaining terms.

(e) To remove, suspend, call explanation from any of the members, office bearers of the members of the Managing Committee if his continuance as such is detrimental to the cause of the College Association.

(f) To modify amend, and or delete any of its Rules and Regulations.

(g) To consider and pass or alter the budget for the college Association as prepared and passed by the Managing Committee and to adopt the Annual Accounts, Auditors Report etc.

5. POWERS, DUTIES AND FUNCTONS OF THE MANAGING COMMITTEE :

Without prejudice to the General Rules of the College Association the Managing Committee shall have the following powers :-

(a) To manage the affairs of the College Association with the concurrence of the "Board of Trustees".

AUDITING OF ACCOUNTS :

The accounts of the College Association shall be audited every year by the Chartered Auditor approved by the Managing Committee.

The College Association shall have perpetual succession and common seal and shall sue and be sued by the said name.

CHANGE OF THE RULES :

The rules of the society can be changed only in the meeting of the General Body attended by more than 40% members.

PROCEDURE FOR DISSOLUTION OF SOCIETY :

If the society cannot run its affairs than the society can be dissolved as per provision under Rules 13 and 14 of societies Registration Act, 1860.

OTHERS :

- a) Renewal of Institute/College management society registration will be made from time to time.
- b) The Institute/College shall pay salaries to the staff not less than the corresponding categories of employees in the State Government of Uttar Pradesh.
- c) Service Rule shall be made for the employees pension and all other facilities shall be given according to AICTE/NCTE/Nursing Council of India/ Rehabilitation Council of India/Government/Affiliating University norms.
- d) The institution shall follow all the rules and orders given by the U.P. Government time to time.
- e) Institute/College will be kept in prescribed order books, register and files.
