context, be deemed to include the Trustee or Trustees (or the time being in office or their successors in office) of the other part.

Whereas, the Settlor is desirous of creating an irrevocable Public Charitable Trust which shall be a voluntary, charitable, nonprofit-making, non-political and non-sectarian organization pledged to the service of providing social welfare activities, charitable activities, education, social, economic and health services to the public at large irrespective of caste, colour, creed, religion and sex.

And whereas the Trustees have at the request of the Settlor agreed to act as the first Trustees of these presents as testified by their being parties to and executing these present and whereas it is necessary to declare the objects and terms of the public charitable trust being constituted under these presents.

6.7 A contribution made to the Trust shall be received only in the name of the Trust and any investment made out of the Trust Fund shall be in the name of the Trust.

ARTICLE 7 : ALTERATION EXTENSION OR ABRIDGEMENT OF THE OBJECTS OF THE TRUST

7.1 The Board of Trustees may alter, extend or abridge the objects or regulations of the Trust either wholly or partially at meeting of the Board of Trustees. Provided that such alteration, extension or abridgement of the objects of the Trust shall only take effect by a majority at a meeting of the Board of Trustees provided that all the Life Trustees have consented to such alteration, extension or abridgement of the objects of the Trust;

7.2 In case the votes of Board of Trustees are equally divided then the matter shall be decided according to casting vote of the Chairman of the meeting.

ARTICLE 8 : IRREVOCABLE TRUST

8.1 The said Trust shall be and remain irrevocable for all times subject to the Article 7 and clause 3.14. However, the Settlor do hereby reserve power also to relinquish, release, disclaim, surrender and determine all their rights, title, interest or powers in the trust and Trust fund;

8.2 The said Trust shall be extinguished if the fulfillment of its purpose becomes impossible by destruction of Trust property or otherwise.


