

- (xiii) To establish take over, run maintain a center or centers for senior citizens or retirement homes or old people homes with facilities for boarding, lodging, health care nutrition, recreation etc, as may be necessary.
- (xiv) To construct low cost building and houses for the poor, disadvantaged and those in distress, especially in the rural and/or urban slums or wherever found necessary.
- (xv) To conduct and organize seminars, workshops, conferences, meetings, public lecturer etc;
- (xvi) To provide assistance to approved funding agencies in verification of financial statements and progress reports of the voluntary organization pertaining to the said development projects and programmes in India.

- (ix) To accept in cash or kind donations gifts, grants contributions (as corpus or otherwise) and to collect interest and other income of the trust for being utilized for furtherance of the aims and objectives of the trust.
- (x) To purchase or to take on lease and, building and other immovable or moveable properties in the name of the trust.
- (xi) To invest dispose off transfer and otherwise deal with monies assets and properties for the time being of the trust in such manner as the law permits and proper to do in carrying out the objects of the trust.
- (xii) To pay all expenses preliminary or incidental to the formation of the trust and its registration and for management and administration for the same.
- (xiii) To do all such act, deeds and things and extend all such other assistance to the said voluntary organizations as may be necessary and incidental to the attainment of aforesaid objects.

5. Board of Trustees:

- (a) The management and control of the trust and the trust properties shall vest in the board of trustee which shall comprise of three trustee's including the chairman and the Managing trustees all the declarant herein will be the Settler. The Board of Trustees shall determine the strength of the Board from time of time.
- (b) The tenure of the first Board of Trustees shall be for a period of and provisions for retirement of such board of trustee shall be applicable in respect of them only after first five years.

(c) All other Trustees to be appointed subsequently will hold office for a period of three years after which one third of them shall retire by rotation on the basis of their seniority.

6. Appointment of new trustees

Subject to the provisions contained in clause 4 mentioned above, the appointment of new trustees shall be governed by the rules as follows:-

- After the completion of the tenure of office of the trustees, they shall retire but shall be eligible for reappointment.
- In case of vacancy/vacancies, new trustee shall be appointed from among the representatives of voluntary organizations, funding agencies and independent experts in the field of development, finance legal and other related matters.
- Filling in of vacancies shall be by a decision of the board of trustees, as far as possible, efforts should be made to fill in the vacancies by unanimous decision failing which the majority decision shall prevail.
- If and as often as the trustees of these presents shall die or desire to retire or refuse to become incapable to act in the trust thereof,



9. Power to appoint committees.

The board of trustees shall be entitled from time to time to appoint with or without remunerations and on such terms and conditions as they may think proper, to appoint committee as they may think proper to function under the authority and control of the trustees for carrying out the objects of the trust of these presents or management thereof and invest them with all such powers including power to incur all such expenditure as may be necessary for carrying out the object of the trust.

10. Power of determine all questions of doubt or difficulty.

It shall be lawful for the board of Trustees to settle and determine all matters of interpretation of THESE PRESENTS as well as the matters of difficulty, doubt and disputes and all questions arising in the course of or incidental to the administration, management and execution of the trust and powers of these presents and any such statement and determination shall be valid, binding and conclusive and shall not be objected to or reopened upon any ground whatsoever.

11. Power of Compromise.

The Board of Trustees shall have the full powers of settle compromise or compound out the court, all suits, action, and other proceedings and to settle all or other proceedings, differences of demand, and adjust the settlement of all accounts relating thereto and as fully as if they were absolutely entitled to the trust fund and without being answerable for the loss occasioned thereby

The trustee shall, at their discretion, make all such dispositions of the properties moveable forming part of the trust fund or any part thereof and

All money forming part of the fund and requiring investment shall be invested in any of the securities authorized by law for investment of trust fund which are permissible under section 11(5) of Income Tax Act, 1961 or shall at their discretion sell and/or realise the same or any part thereof.

15. In whose name money should be invested.

All money forming part of the trust fund and requiring investment shall be invested and the conveyance of assurance in respect of any immovable property/properties forming part of the trust fund shall be obtained in the name/names of the trustees for the time being of the board of trustees.

16. Opening Bank Account.

The Board of trustees of Maharsfi Moolchand Sadav Memorial Trust may open any banking accounts with such scheduled bank as may from time to time be determined by the trustees and shall forth with pay or cause to be paid the rents, income, dividends and all other money forming part of the trust fund to the credit of any such
