- 1- I, Shashikant Yadav age 48 years S/o Sri Ramdeo Yadav R/o Village-Baijalpur, Post-Amargarh, District-Pratapgarh U.P. do hereby execute and registered this Trust deed of "Ramraji Ramdeo Public trust, Baijalpur with his signature before the witnesses in the memory of his Grand father Late Shri Ram Phal Yadav. I steller is creating the trust with Rs. 20000.00 Which will be the trust money.
- 2- Name of the Trust - This Trust shall be known as "Ramraji Ramdeo Yadav Public Trust Baijalpur, Amargarh, Pratapgarh" and its short name will be "R.R. Yadav Public Trust Baijalpur, Amargarh, Pratapgarh"
- 3- Registered office of the Trust - The Place of Trust and its registered office will be at Village-Baijalpur, P.O.-Amargarh, District-Pratapgarh, Uttar Pradesh.
- 4- JURISDICTION :-
  - (a) Whole of India.
  - (b) The provisions of Indian trust act 1882 and Income Tax Act 1961 will be applicable along with terms and conditions of this trust deed.
- 5- The trust is created for the purposes of Public Welfare, Health, Character, morality, Nationality.

- 7- **AIMS AND OBJECTS OF THE TRUST :-**

  - (ii) To promote national integration and encourage, support and develop social welfare programmes for balanced growth of the nation;
  - (iii) To provide financial or any other assistance towards relief and rehabilitation or the populace affected by calamities like cyclones, earthquakes, epidemics, fire, famine floods, war, riots, etc.
  - (iv) To establish, maintain or support a home or homes for windows, orphans, special centers for providing shelter and protection to women and children in distress;
  - (v) To create and promote enlightened public opinion on various issues affecting the citizen of India.
  - (vi) To encourage conservation, a forestation and protection of the environment including birds, animals and all species of plants and animals.
  - (vii) To provide food, clothing and shelter to all those in need and provide pecuniary assistance to those unable to fend for themselves due to old age, disease or any physical or mental handicap.
  - (viii) To undertake, or assist undertaking, projects like digging wells, providing drinking water facilities, fodder for cattle, grains, seeds and fertilizers for farming, agriculture tools etc.
  - (ix) To establish, maintain or support dharmashalas, rest houses, convalescing homes, health and immunization camps, infirmaries, or phanages.
  - (x) To provide assistance for building or maintaining roads, national and state highways, bridges, reservoirs irrigation tanks, tube wells, recreation centers, parks, playgrounds for children, libraries, museums, are galleries, cultural centers for the benefit of the public and improving their quality of life.



- (xi) To support the initiative of any individual group or organization in promoting education both formal and informal and for children and adults.
- (xii) To establish, take over, run, maintain, assist and support hospitals, including mobile hospitals, charitable dispensaries, maternity homes, sanatoriums, medical center, medical camps, health education and family planning centers, children welfare centers, natural health centres, nutrition centers and any other institutions or forum for preventive, curative or primary health care and treatment.
- (xiii) To establish take over, run maintain a center or centers for senior citizens or retirement homes or old people homes with facilities for boarding, lodging, health care nutrition, recreation etc, as may be necessary.
- (xiv) To construct low cost building and houses for the poor, disadvantaged and those in distress, especially in the rural and/or urban slums or wherever found necessary.
- (xv) To conduct and organize seminars, workshops, conferences, meetings, public lectures etc.
- (xvi) To provide assistance to approved funding agencies in verification of financial statements and progress reports of the voluntary organization pertaining to the said development projects and programmes in India.
- (xvii) To establish, takeover, run maintain, assist and support schools and colleges including kinder garden, primary middle and inter and Degree colleges & T.T.C. all over India.
- (xviii) All other trustees to open and maintain account or accounts for the trust in and scheduled bank or banks for the purpose of keeping the moneys and to operate on the same or to authorize anyone or more to operate upon them.
- (xix) To accept in case or kind donations gifts, grants contributions (as corpus or otherwise) and to collect interest and other income of the trust for being utilized for furtherance of the aims and objectives of the trust.
- (xx) To purchase or to take on lease land, building and other immovable or moveable properties in the name of the trust.

- (xxi) To invest dispose off transfer and otherwise deal with monies assets and properties for the time being of the trust in such manner as the law permits and proper to do in carrying out the objects of the trust.
- (xxii) To pay all expenses preliminary or incidental to the formation of the trust and its registration and for management and administration for the same.
- (xxiii) To do all such act, deeds and things and extend all such other assistance to the said voluntary organizations as may be necessary and incidental to the attainment of aforesaid objects.
- (xxiv) All activities financed from the funds shall be conducted in accordance with the ideals and objects as stated hereinabove and on discrimination shall be made on grounds or religion caste creed sex or political affiliation of the implementing agency or beneficiary.
- (xxv) To aware the people for the environment and to save it, To break or stop the pollution (air, water and otherwise)
- (xxvi) To save the water and other natural resources, river, ponds, tanks, channels, forest , medicine ayurvedic natural produces and natural resources.
- (xxvii) To promote national language its subsidiary languages Bhojpuri, braj, Awadhi and Hindi kavyas, lok geet, lok sahitya, local custome.
- (xxviii) To learn yogas naturopathy ayurvedic treatment & surgery.
- (xxix) To save national book, to teach Vedas, Upnishads, Ramayan, Geeta, Mahabharat & other religious books.
- (xxx) To provide for education and scholarship, Hostals to poor students of general classes, Backward classes, schedule class and schedule tribe.

8- **Board of Trustees –**

- (i) There shall be a board of trustees in which Hereditary Trustees of para-6 will continued of their lifetime and after the death of any Hereditary Trustee legal heirs successors will be hereditary trustee automatically as of right without paying any fee.
- (ii) Name and description given in para-6 as life trustee will be also be member or trustee for the board for their lifetime, their successors, heirs could not claim to become the trustee as a right.
- (iii) **Appointment of New Trustee –** The Chairman, Secretary, have right to appoint new trustee after receiving fee of Rs 1000.00 minimum, office of newly appointed trustee will be of three years. After expiry of three years same trustee may be appointed as fresh but they could not claim to become a trustee as of right.
- (iv) Subject to the above noted provisions other trustees may be appointed as Honourary trustee who have specialization in Law, Trust, Industrial, Economical, Technical, Medical, Social, Matter for the better management or to take opinion but the honourary trustee shall have no right to vote in any election of management of trust, institution established by the Trustist.
- (v) **Disqualification of Trustee –**
  - (a) The person should not be below the age of 20 years at the time of appointment.
  - (b) Unsound mind or mentally disabled, leppers are prohibited.
  - (c) The person of criminal history or upon whom any cognizable & non bailable offence registered upon any police station.
  - (d) Setlors of the Trust are exempted from above noted disqualifications.

9- **Management of Trust-** The chairman and secretary have power to constitute committee one or more for the purposes of trust. The committee will perform the job or any other work according to direction of Chairman and secretary and to report the same.



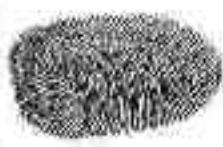

- 10- **Management of institution established by the Trust** – Any institution like Degree College, Post Graduate College, Intermediate college, High School, Junior or Primary School established by the trust shall be regulated by a separate management. According to rules of state universities act, Intermediate Education Act 1921, or Basic Shiksha Adhiniyam as well as Teacher training school, Technical, Medical colleges will also be regulated by the concerning laws. In the election of any institution established by the trust. The Hereditary Trustee, Life Trustee appointed general new trustee will have right to vote and candidature while on the post of manager only Hereditary Trustee may be elected. Other trustee have no right to elect as manager.
- 11- **Decision** – All decisions shall be taken in open meeting of trustees and decision shall be upon majority consent or voting system.
- 12- **Appointment of Officer, Employees for the Trust-** The Chairman and Secretary will have right to appoint officer, employees for the trust in number as necessary. Salary and other benefits ought to be awarded them according their work and agreement.
- 13- **Audit and account-** Account of the trust income, expences, payment in salary, construction distribution gift shall be maintained in the direction of chairman, secretary of the trust or any accountant appointed for the same.
- 14- All the money grant, fee, income of any type will be deposited in any nationalized bank, post office or other bank governed and established or recognized by the Reserve Bank of India or Banking Regulation Act.
- 15- Account shall be in the name of the trust and shall be operated by the chairman or secretary or both as they like.
- 16- **Meeting of Trust** - Chairman shall call the general meeting of trust once in the year in the month of march every year in which all matter will be considered and accounts, audits report will also be considered and approved other meeting may be called at anytime after notice of 7 days by the chairman or the three or more trustee may request the chairman to call the meeting.

- 17- Election of trust committee will be held after expiry of 5 years.
- 18- Register of trustee will be maintained by the chairman and secretary.
- 19- Cash book, receipts shall also be maintained and protected by the accountant/clerk appointed for the purposes, year to year in the guidance of chairman and secretary.
- 20- **Amendment-** Any amendment in the trust deed may be incorporated with the proposal of trustee more than 50% present in the meeting. All amendments in trust deed will be registered.
- 21- The settlor chairman and secretary shall continued during their lifetime. No election of above post shall be held during the lifetime of trust settlor chairman and secretary.
- 22- Any trustee other than hereditary trustee may be terminated after conviction or after implication in any offence of moral turpitude.
- 23- **Power to make Rules-** the chairman and secretary have power to make rules for the appointment of employees officer, constructions or for any activities of trust.
- 24- Trust may established its branches any province, district in India for the extension of trust purposes as well as Branch office of the Trust may be open at any place.

- 25- **Property-** All the property moveable and immoveable will be purchased in the name of trust from the fund of trust by the chairman and secretary and trust may hold the landed property in the name of its institutions also from the fund of trust. Trust may take lease, mortgage of any property and will also entitled to execute sale, exchange, lease, mortgage deed regarding the property of the trust. All type of execution of deed may complied after the meeting of board of trustees and permission of authorities as required by the law in the interest and benefit of trust. The Trust will open the Degree college at first after the registration of Trust in the Name of "R.R. Degree College".
- 26- **Disputes** – Dispute regarding trusteeship, employee, officer, trust property accounts will be decided by the chairman or secretary. Chairman or secretary may file any suit, appeal, revision review, restoration, writ petition in any court with his own signature as chairman or secretary of the trust and in any case against the trust. Chairman/secretary may file written statement and will have power to file document, affidavit, vakalatnama and also empowered & to adduce evidence if chairman/secretary is unable to perform such act. He may appoint any trustee to perform such duties with the consent of chairman by a written power of attorney.
- 27- Chairman/secretary will have power to receive any gif, donation, fee, levy grant for the trust and to gave him receipt of same with his own signature.

**28- Power of Trustees-**

- (a) Trustees have power to contest the election and to vote subject to other provisions of the trust.
- (b) Trustee will have power to participate in annual and other meetings of the trust.
- (c) For the benefit of trust and to Assistance or advise officer of the trust for any action, construction, donation, collection of fund, property, distribution, or to aid any person or class as necessary.
- (d) To raise any question against any trustee for wrong activities.
- (e) Any other matter which is just and convenient for the purposes of trust.
- (f) To approve the acts and action, account audit of trust.

29- **Amalgamation** – The trust will have power to amalgamate any trust or society in this trust after the confirmation in meeting of trustee.

30- **Removal of Doubt-** The hereditary trustee will continued as per-degree per step, if any degree several son and daughters. They all will be hereditary trustee but the chairman or secretary may be chosen by majority in case chairman and secretary nominated his successor during lifetime for the chairman or secretary. No question of selection by majority will be arises.

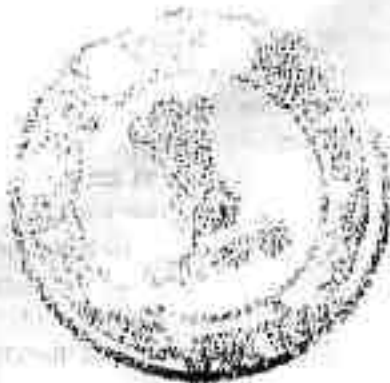
