1. NAME OF THE SOCIETY -

5. MEMBERSHIP OF THE SOCIETY -

07

(1) The number of members of the society shall not be less than seven.

(2) No membership fees shall be payable by any member of the society.

(3) The members of the society shall be honorary workers of the society and shall work without any remuneration.

Provided that the Chairman of the Governing Council, in his discretion, may make provision for reward or pecuniary benefit to those members of the society, who, in the opinion of the Chairman, render exceptional service in managing the affairs of the society and of the college.

(4) It shall not be open for any one to apply for membership of the society.

(5) The Chairman of Governing Council, in his discretion, may invite any person for becoming member of the society and thereupon, after such consultation as may be deemed fit by the Chairman or without such consultation, the Chairman may grant membership or may refuse membership.

(6) The Chairman of the Governing Council may grant membership of the society by invitation to such persons and to as many of them as the Chairman may deem fit.

(7) The decision of the Chairman of Governing Council in respect of grant or refusal of membership shall be final and shall not be called in question.

(8) If membership of the society is granted by the Chairman of Governing Council to a person, the name of such person shall be entered by the Chairman in the membership roll of the society and such person shall become member of the society from the date on which he enters the membership roll of the society.

(a) The Governing Council shall consist of one person as its Chairman as provided hereinafter and seven persons as Members of Governing Council.

(b) The Principal of the College shall be the ex-officio Member of the Governing Council.

(c) Twenty-five percent of the Members of Governing Council shall be teachers of the college (including the Principal).

(d) The Teachers (excluding the Principal) referred to in clause 10 (c) above shall be the Members of Governing Council for a period of one year by rotation in order of seniority.

(e) One Member of Governing Council shall be from the non-teaching Class - III employees of the college selected for a period of one year by rotation in order of seniority.

(f) Subject to the provisions of clause 10 (1) (c) above, no two members of the Governing Council shall be related to each other within the meaning of explanation to Section 20 of the U.P. State Emblem Act, 1973.

(g) In view of number of members of the Governing Council the Governing Council shall have three persons as its ex-officio members, namely, Principal of the College, one teacher of the college and one person from the non-teaching Class-III employees of the college. Rest of the five Members of Governing Council shall be the Chairman of Governing Council and four members of the college.

(2) Functions & Duties of Governing Council:

(a) The Governing Council of the society, headed by the Chairman of the Governing Council, shall be the governing body of the society and the same Governing Council shall be the governing body of the college. The management of the affairs of the society and of the college shall vest in the Governing Council through its Chairman.

(b) All the properties of the society, movable and immovable, shall vest in the Governing Council and all document relating to and affecting them, shall stand to be taken in the name of the society. All documents relating to the property of the society shall be executed for and on behalf of the society by the Chairman of the Governing Council, or if the Chairman of the Governing Council is not able to do so for any cause whatsoever, by any other member of the society authorized for the purpose by the Chairman of Governing Council.

(c) The Governing Council shall act through its Chairman and shall work under the directions of its Chairman.

(d) The Governing Council shall be a deliberative assembly.

(e) The Governing Council shall meet as and when convened by its Chairman at a place specified by its Chairman. The agenda of meeting of Governing Council and procedure of its meeting shall be determined by the Chairman.

(f) The Governing Council shall prepare the annual report of the work of society for presentation in the Annual General Body Meeting and shall also present in the Annual General Body Meeting the accounts of the society for the year ending on 31st March last preceding the date of the Annual General Body Meeting.

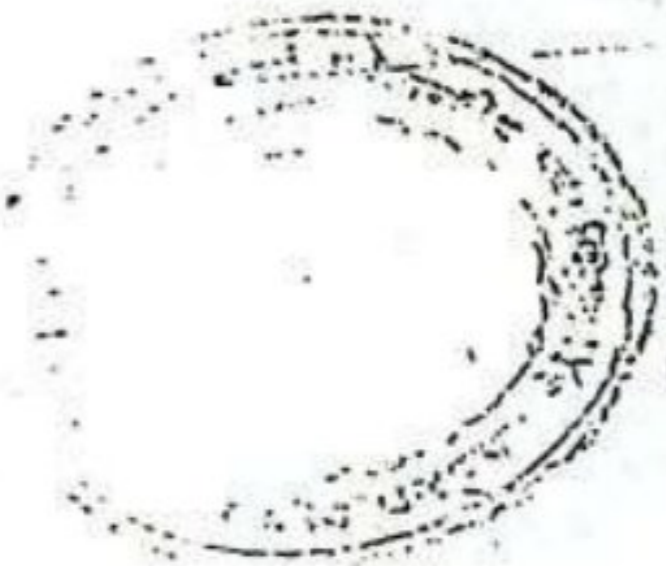

(g) Absence of any Member of Governing Council or any vacancy in the office of Member of Governing Council shall not preclude the meeting of Governing Council or invalidate its proceedings in any manner unless otherwise directed by its Chairman.

(h) It shall be the duty of the Governing Council to ensure that all the original documents pertaining to income and expenditure of the college including the accounts of the society are placed before any person or persons authorized by the Vice-Chancellor or before the Panel of Inspectors appointed by the University to which the college is affiliated.

(i) The Governing Council through its Chairman shall have power to do and cause to be done all such acts that may be resolved to be done by its Chairman in order to manage the affairs of the college.

(j) The decision of the Chairman of Governing Council in respect of a matter concerning the Governing Council shall be final and binding on all concerned.



(k) Chairman of Governing Council:

E.H.C. Mankapur-G.

(a) Sri Kirti Vardhan Singh, son of Sri Anand Singh, resident of Mankapur Kot, Mankapur, Gonda, Uttar Pradesh, who is one of the founder members of the society, shall be Chairman of Governing Council.

(b) Sri Kirti Vardhan Singh shall hold the office of Chairman of Governing Council during his lifetime and shall have the right to nominate his successor to the post of Chairman of the Governing Council. The successor so nominated shall be the Chairman of Governing Council for life unless otherwise provided by Sri Kirti Vardhan Singh.

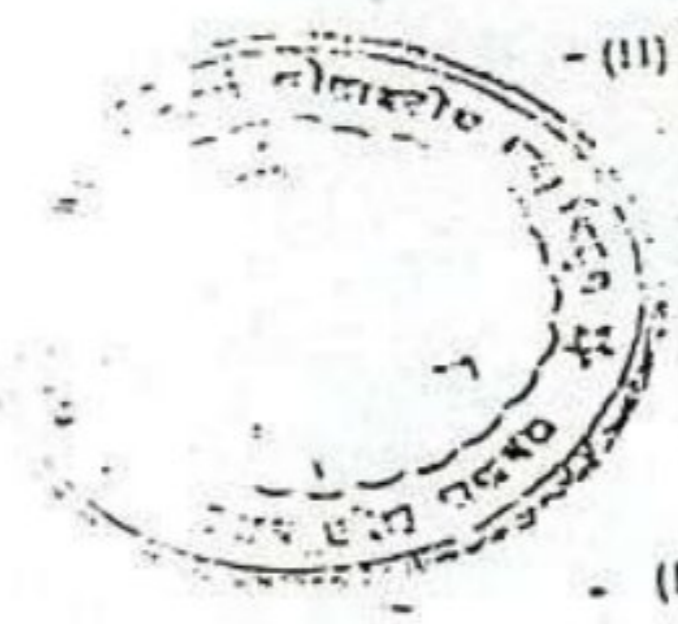

Provided that the transfer of any immovable property belonging to the society shall be subject to the provisions contained in Section 5-A of the Societies Registration Act, 1860 (as applicable in UP) so long as the said Section 5-A is in force.

(m) The Chairman of Governing Council shall have full power to do all such things as may be deemed by the Chairman to be necessary or expedient for the management of the affairs of the society and of the college or which in the opinion of the Chairman may be conducive to the attainment of the objects of the society.

Whenever the Chairman removes a Member of Governing Council, the Chairman shall nominate at the earliest another member of the society as Member of Governing Council to fill the vacancy caused in the Governing Council.

(c) The Members of Governing Council shall work under the direction of the Chairman of Governing Council and shall perform such work as may be assigned to them by the Chairman.

(ii) Transact any other business that may be fixed in the agenda determined by the Chairman of Governing Council or may be allowed by the Chairman or may be brought forward by any member of the society with the previous permission of the Chairman.

5-11. AMENDMENT OF MEMORANDUM OF ASSOCIATION & OF RULES :

(i) The Memorandum of Association of the society and the rules and any other rules or regulation hereafter made and by whatever name called may, from time to time, whether by way of modification or addition or revocation or re-enactment whatsoever, be amended by the Chairman of Governing Council and his decision to amend shall be final and shall not be called in question.

Provided that for altering, extending or abridging the object of the society or for amalgamation of the society either wholly or partially with any other society or for amalgamation of the society either wholly or partially with any other society, the procedure contained in Section 12 of the Societies Registration Act, 1860 (as applicable in U.P.) shall be followed so long as the said Section 5-A is in force.

Provided further that the Constitution of management of college i.e. of the governing council contained in Clause 10(1) of these Rules can only be changed with the prior approval of the Vice Chancellor of the university to which the College is affiliated.

A copy of every change made in the rules of the society and ultimately in every change of address of the society, certified by not less than three of the members of the Governing Council shall be sent to the Registrar within 15 days of the change.
