- 9- In the further event of any Managing Trustee Dying or ceasing to be a Managing Trustee without leaving in his place any of his/her Male/Female Lineal Descendant Surviving him, the remaining Members of the Board of Trustees shall elect a person to be a Managing Trustee from amongst the then surviving 'Male/Female lineal descendants of Managing Trustee.
- 10- In the Contingency of the office of Managing Trusteeship, in Accordance with the above, depending upon any person who may be a minor then, during his minority, the Natural Guardian, or in case of one or more Guardian whosoever may be Appointed by the Court as the guardian of the property of the minor shall act as Trustee until the minor(s) attained majority. Such person who was minor shall, on attaining majority, act as trustee.

- 19- The Trust Fund may be augmented by the income from the initial Fund and Also by Donations and other Contributions from time to time.
- 20- The Funds of the Trust shall not be applied for any purpose other than the object of the Trust stated in Para 22 below:
21. In case absent of male are female major legal heirs – The minor legal blood relative legal heirs in title inter in to trust as the trusty.
- 22- The objects of the Trust are as under:-
- (i) To open, Run, Continue an Educational and Vocational Institution that is a High School, Intermediate College, Degree College BTC, B.Ed, B.P.Ed in healthy surroundings, Job oriented course Medical Education & Charitable Hospital, Teachers training School etc.
 - (ii) To provide Technical Education.
 - (iii) To provide Computer and Information Education.
 - (iv) The Board of Trustees may seek affiliation of any recognized Institution, University, Educational Boards, or other Institution confirming and the information at standard for better functioning, of the Institution.
 - (v) To Establish, maintain and run a Boarding House and Residential Accommodation for Students and those connected with the Institution.
 - (vi) To Accept Donation, Grants, presents and other offerings and to deal with the same for the purpose of the Trust.
 - (vii) To Train and Equip the pupils so as to be Self-Supporting in an honorable and decent way of life so as to develop into good, healthy and progressive citizens.
 - (viii) To Agricultural forming, product of seed and other development of agricultural.
 - (ix) To work for social welfare.
 - (x) Medical care maintenance Yoga modification, Satsang Etc. for the senior citizen available.
 - (xi) To making an old age home for old age citizens.

10- The Board of Trustees of the Trust shall have the power to make any such amendments to the Trust Deed as may be necessary for the proper carrying out of the objects of the Trust and such amendments shall be valid and binding on all the beneficiaries of the Trust as if they were contained in the original Deed.

11- The Trust Deed may be amended by the Board of Trustees and such amendments shall be valid and binding on all the beneficiaries of the Trust as if they were contained in the original Deed.

12- The Board of Trustees shall not be bound to apply the income of the Trust for any purpose other than the objects specified in clause 10 above.

13- In case of any dispute or difference between the Board of Trustees and the beneficiaries of the Trust, the same shall be referred to the Court of Law for its decision.

14- The Board of Trustees shall have the power to make any such amendments to the Trust Deed as may be necessary for the proper carrying out of the objects of the Trust and such amendments shall be valid and binding on all the beneficiaries of the Trust as if they were contained in the original Deed.

- (xii) To provide education, training and self dependence to physically Handicapped, mentally weak and blind children.
- (xiii) To provide employment and self depend training to all categories of the society.
- (xv) To women employment work to upliftment of the socially weak women.
- 23- Rules may be framed for the proper Administration of the Trust, but such Rules shall not be against the objects of the Trust as in Clause 16 above.
- 24- For the Removal of doubts it is hereby declared that this Trust, its objects and its Implementation shall not be for the benefit of any particular caste or religious community as such.
- 25- The Board of Trustees shall meet as often as may be necessary or convenient to transact Business. The Board of Trustees might transact Business and take decisions also by Circulation of papers.
- 26- All decisions of the Board of Trustees shall be taken either. Unanimously or by majority and if the Board divided, the Managing Trustee will have the casting vote.
- 27- Without prejudice the powers of the Board of Trustees the Managing Trustee shall manage and Administer the affairs of the trust and shall also exercise such power and function as may be delegated to him by the Board of Trustees.
- 28- The Management and Administration of the Trust shall vest in the Board of Trustees.
- 29- The Funds of the Trust shall be invested in Bank Deposits, Government Bonds or such other Appropriate Security as the Board of Trustees may decide.
- 30- The Board shall have power to borrow Monies for the purposes of the Trust.
- 31- Without Prejudice to the generality of the provisions contained above the Board of Trustees may also empower the Managing Trustee to represent or Act for the Trust, in any matter concerning the properties, Funds, investments, Borrowings and the making or Cancellation of any Instruments for any of these purposes.

Managing Trustee

- 32- The Managing Trustee may authorize any of the Trustees to act on his behalf and to operate Bank Accounts etc. If the managing trustee finds that some property is making a loss or it is not possible to manage that property properly then the managing trustee would be empowered to sell that property and would invest that amount for welfare of the trust.
- 33- The managing trustee is empowered to ease the property of the trust to generate money for the welfare of the trust and to purchase the immovable property in favor of Trust.
- 34- The Trustees shall have power to accept Donations in Money or otherwise for the purposes of this Trust.
- 35- The Trustees shall have power to Appoint personnel to organize and promote the objects of the Trust and to regulate their conditions of Service, including, matters of discipline.
- 36- All Acts and proceedings of the Trust shall be taken and conducted in the name of the Trust.




