

Haridwar, (U.P.) here in after called the FOUNDER for transferring the corpus of the trust here by declared to the ownership of the trustees appointed under this deed and in accordance with the terms and condition set forth here in.

WHERE AS the founder is desirous of creating a trust under the name and style of *Dr. Hari Shankar Misra Mahavidyalaya Mahilamata, Haridwar*. for the fulfillment of the following aims and objects:

1. The trust is created for carrying out the following objects of public charity and for the benefit of the member of the general public without any distinction of caste, colour, creed, sex, sect age and/or other natural or man made difference.
2. Practice and propagation of yogi's way of life and establishing its sanctity & utility amongst the masses by providing free educational camps and demonstrations and holding seminars.
3. Propagate the study and use of Ayurvedic herbs and Alopah and Homeopath medicines in curing diseases and ailing persons and laying stress on the need of fresh researches in Ayurvedic, Alopah and Homeopathic fields.
4. Cultivation of Ayurvedic herbs, manufacturing of Ayurvedic medicine under its own potent name, trading and distribution amongst the masses.
5. To establish and run Educational Institutions Vocational/Professional/Technical, and/or Academic Institutions, School, Libraries, Hostels, Hospitals, Nursing School, Nursing College, Nursing Homes and Medical Colleges, Guest Houses, Boarding Houses, Dharmshalas, Marriage Homes, Banquet Hall and other Community Services.

- 6. To launch a campaign for literacy amongst so-called deprived person, down trodden and adult people and to organize educational tours.
- 7. To carry on any act only and wholly for charitable, scientific, literary or educational purposes, and the advancement of any other object of general public utility not involving the carrying on of any activity for profit without reference to caste or creed.
- 8. To grant medical relief in any form to the blind, deaf, and dumb, diseased maimed, disabled, infant, poor, destitute, widows, children and other deserving persons as may be deemed fit by the Trustees from time to time.
- 9. To award stipends and scholarships including scholarship for going abroad or anywhere in India for further studies to suitable students or to give school and collage fees and/or cost of books to deserving and/or poor students, irrespective of caste or creed.
- 10. To advance loans to promising young men or girls to prosecute their studies or to set them selves in business, profession or vocation. To give donations to persons and/or institutions doing the work of social, moral or spiritual uplift of humanity.

AND WHERE AS THE FOUNDER here to has settled on trust in cash a sum of Rs. 11000/- [Rs. Eleven thousands only] wholly and exclusively for the purpose, aims and objects of the trust.

AND WHERE AS the trustees appointed hereby have expressed their consent to be invested with the ownership of the subject matter of the trust for the purpose of carrying out the objects set out here in and above, and have accordingly taken possession of and assumed the legal ownership over the aforesaid sum.

NOW THIS DEED THERE FORE WITNESSTH AND IT IS HERE BY DECLARED BY THE FOUNDER AS FOLLOWS

1. The founder here by conveys, transfers and grants a sum of Rs. 11000/- (Rs. Eleven thousands only) in to the trustees for the purpose and objects specified here in that it is to be used and appropriated by the trustees for carrying out and fulfilling the said purposes and objects and the founder here by relinquishes for all time any claim or interest in the said property.
2. The said property shall form part of the corpus and property of the trust, here in after described at the 'TRUST PROPERTY'.
3. The term of the trust shall be 'CHARITABLE TRUST'
4. The term 'TRUST PROPERTY' shall mean and include the aforesaid sum of RS. 11000/- all additions and accretions there to the income arising there from and all other property which may from time to time vest in or may become due to the trust, or be received by it from any source. In particular any voluntary contributions.
5. Received by the trust either in money or money's worth always form part of the corpus of the trust and shall be included in the 'TRUST PROPERTY'
6. The head office of the trust shall be at Village & Post Malihamau, Hardoi (U.P.) for the time being but the trustees are at liberty to transfer the same to such other place [s] as may be decided time to time.

7. The trustees shall hold and stand possessed of Trust Fund upon "TRUST" and shall be empowered.

- (A) To recover the interest dividend and income of the Trust fund and to pay out of the same; Charges for collection and other incidental out goings, if any.
- (B) To pay or utilize the balance of such interest, dividend and other income of the Trust Fund, Here in after referred to as the "NET WORTH" and if the trustees so desire the corpus of the Trust Fund or any one or more of the charitable purpose hereinafter specified to the extent that the same shall relate to anything done or to be done within the territories of India, without reference to caste or creed and to such shares and proportions and such manner in all respects as the Trustees shall in their absolute and uncontrolled discretion deem fit.
- For any other object of general public utility.
  - For any other object as may be regarded as charitable under the provisions of Income Tax Act, 1961 or and statutory modifications or reenactments thereof for the time being in force.

IT IS HEREBY DECLARED THAT the Trustees shall be entitled to pay, utilize or apply the income arising from the trust fund only for the benefit of general public irrespective of caste, or community on all or anyone or more of the charitable purposes as defined U/s 2 [15] of the Income Tax Act, 1961 which includes relief of the poor, education, medical relief and the advancement of any other object of general public utility.

8. It is hereby declared that no part of the income derived from the Trust property shall be used directly or indirectly for the benefit of any persons as prescribed in the provisions of Income Tax Act as amended from time to time. The investment of Trust Fund shall be in

(iv) On his absenteeism from all consecutive meeting held, With in one year without seeking proper permission or without adequate cause shown to board of trustees.

- D- The board of Trustee may select appoint and co-opt. One or more trustees provided the number of trustees in the board at any time should not exceed fifteen.
- E- The Trustees named at serial Nos. 1 to 4 in sub clause [a] here of shall hold office for life and shall be called as the life trustees and the other trustees who are selected, appointed or co-opted by the board shall hold office in the first instance for a period of one year only, but they shall be eligible for re-appointed after their retirement on the expiry of the said period.
- F- In the event of the death of any of the Trustees named in sub clause [A] his nominee shall always be from amongst the lineal descendents of the founder and/or their wives, and in case of no male descendents, their female descendents or their sons or their grandsons shall be the Trustees.

10. The Trustees, in carrying out the aforesaid objects of the trust shall meet all the necessary expenses out of the Trust property or from income arising out of it.
11. The Trustees shall have full powers to do everything in or for the furtherance of this trust or which is considered beneficial or conducive there to, subject to this conditions held down in this Trust Deed.
12. The Trustees shall apply all income derived from Trust property solely and exclusively for the purpose/object of this Trust only in India. Subject to the restriction imposed vide clause no.7 of this Deed, and where it is not impossible to apply wholly such income only India they shall observe such conditions as are laid down in section 11 of the income Tax

or contributions at their discretion without assigning reason therefore. All such contributions or including any property either movable or immovable has obtained by the trustees shall from part of the corpus of the trust fund being the subject matter of these presents.

B] Such donations, if accepted by the trustees and all other funds and corpus of this trust shall be dealt with as regards their investments and disposal, including deposit with banks, financial institution, joint stock companies, firms and individuals according to the decisions of the trustees but such decisions shall always conform to the rules and conditions of this trust deed.

- 17. The trustees shall be entitled from time to time open and maintain a bank account or accounts in the name of the trust at such bank or banks as they may decide from time to time and may at any time pay or cause to be paid any moneys forming part of the trust fund or the income thereof to the credit of any such account or accounts either by way of deposit or current account or any other account. Any such account may be operated by the Pradhan/bank or as may be authorized by the trustees for the purposes or in such manner as may be decided by the trustees at a meeting of the board.
- 18. It shall be lawful for the trustees to pull down, renovate, rebuild, alter, improve, add to develop or repair any immovable property forming part of the trust fund or the income thereof as they may think fit. The trustees shall also be entitled to enter into any agreement or covenants with the owners or persons interested in any other properties and whether restrictive or otherwise and whether for the benefit of the properties comprised in the trust fund or Such other properties as they may in their absolute discretion think fit from time to time.

19. The Trustees shall cause to be kept true and correct accounts of all assets and liabilities and money received and expenses incurred by them in respect of the trust and, once in every year such accounts together with a balance sheet shall be examined, audited and certified by such chartered accountant or chartered accountants as may be appointed or otherwise they may decide.
- These annual statements of audited accounts shall be adopted and signed by the trustees soon after the same are ready as stated here in All the main account books of trust shall be kept at the head office of the trust or at such other places as the trustees may decide.
20. The Trustees may appoint paid manager and other officer and staff to manage and administer the trust and to maintain the books of account of the trust as well as to carry out correspondence and all other business on behalf of the trust, as may be necessary and to pay their remuneration's.
21. The Trustees may for the time being meet at least two times every calendar year at a time and place to be decided by them for the purposes of transacting the business of the trust and the decision of the majority of the Trustee shall regulate such business provided always that is shall be open to the trustee to make rules and regulations relating to such meetings and conduct of their business.
22. The Prabandhak may call meeting of the board of Trustees by giving each trustee one week's notice in writing or such shorter notice as the trustees may decide from time to time. A notice calling a meeting of trustees may be issued by the secretary or manager or any other authorized person of the trust.
23. The Quorum for a meeting of the Board of Trustees unless otherwise determined. Shall be two or one third of total number of trustees whichever is less. But this shall not affect the powers and rights of the continuing trustees to appoint another trustee to make up the
