- 3. REGISTERED OFFICE:- The Registered office of the Society shall remain in the N.C.T.of Delhi at present it is at:-  
2647, Hudson Line, Kingsway Camp, Delhi-9.
- 4. AIMS AND OBJECTS:- The aims and objects for which the Society is established shall be as under:-



- (a) To arrange, establish and look after and supervise Nursery/Higher Secondary/Primary and upper higher educational institutions and to provide education to the General Public poor and needy children, SC/ST Community/ Seaker Sections as per Policy of the Govt. of India.
- (2) To Open library, Reading Rooms and other Centres to the poor and needy students/children.  
To distribute Award /Scholarships prizes to the eligible Students/Children.
- (4) To work for the promotion of Social Welfare, sports and games for all such other activities.
- (5) To arrange, establish, look-after and supervision and run charitable dispensaries for development of Public Hygiene.
- (6) To propagate and help and fitness culture and carry out programmes seminars, discourses, lectures, film shows to attain the above said aims and objectives.

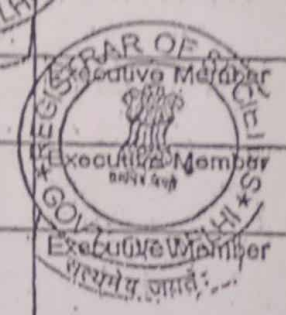

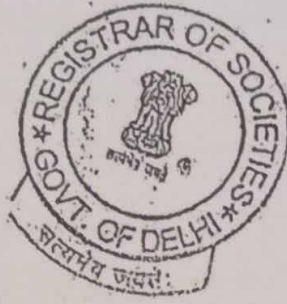
