TRUSTEES of the second part

WHEREAS the settler has decided to establish a fund to setup, run, maintain, operate, of an Educational College for Higher Education anywhere in India imparting training and education of Art, Commerce, Science, Law, Management, medical and medicines and to run a hostel for students simultaneously for the general benefit of society at large without keeping any reservation to any particular caste, religion and community.

WHEREAS it has been decided that the trustees will have and apply for all gifts, contributions, subscriptions and donations for the said fund for public welfare purpose and subject to the trusts, powers and provisions contained in this DEED.

NOW THIS DEED WITNESSETH AS FOLLOWS:

1. The settler in the premises doth hereby transfer unto the Trustees a sum of Rs. 5000.00 (Rupees Five Thousand only) as initial contribution to have and to hold the same unto the trustees before the Trusts hereinafter declared.

- 1) To grant aid to render assistance to other public charitable trusts or institutions.
3. The Trust shall be known as RAMA EDUCATIONAL TRUST. ✓
4. The number of trustees shall not be less than two and not more than six. The trustees shall be trustees for their life time, but any trustee may resign by giving notice in writing to his co-trustees and shall also cease to be a trustee if requested in writing by three fourth of the remaining trustees of the number hereat thereof. Appointment of trustees either to fill up a vacancy or an additional trustee shall be by resolution of the trustees.
5. The general management and control of the trust for the purpose of managing of the trust affairs, properties and carrying out objects of the trust aforesaid shall be vested in the trustees.
6. The trustees will also have the following powers :-
 - a) To apply the whole or part of the income or accumulation or whole or part of the corpus of the Trust properties for one or more of the objects of the Trust say, from time to time determine.
 - b) To convert and get the Trust property and/or to vary the investments for time being and to invest and invested the trust properties either in the purchase or mortgage of immovable properties either in the purchase or mortgage of immovable properties or in shares, debentures of other securities and investments whether authorized by the India Trust Act or not to alter, vary, as the trustees shall in their absolute discretion think fit, provided, however, that accumulation of the income of the trust properties in respect of which notice had been given to invested in accordance with clause (b) of sub-section (2) of section of 11 of the act.
