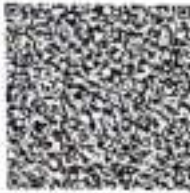

2. **Place:** That the registered office of the Trust shall be situated at Saket Nagar, Rupaidiha, Tehsil-Nanpara, District-Bahraich. UP, India or at such other place or places as the Board of Trustees may decide from time to time .Branch / administrative office can be opened in any part oh the country for the smooth functioning of Trust.
3. **FUND:** The board of Trustees shall hold a sum of [] 100.000 { Rupees one lakh only} this day thereof which may hereinafter be received by the Board of Trustees from time to time as Gifts, Donations Grants, Subscriptions or otherwise for the purpose of the Trust and thr Trust fund shall vest in the Trustees jointly.

5. **NUMBER OF TRUSTEES:** The number of Trustees including the settlers of the Trustees shall not be less than three and not more than seven persons. The Board of Trustees shall nominate and invite persons/persons to be other trustees for such period, as they may deem fit and proper.
6. **TERM OF OFFICE OF THE TRUSTEES:** These Trustees shall hold office for such duration as may be specified by the board of trustees.
7. **CHAIRMAN:** There shall be a chairman for the administration of this trust, nominated by the board of Trustees, who shall be one amongst trustees as specified in para (5) above to such period, in such manner as may be specified in this behalf.
8. **MANAGING TRUSTEE:**
- i. The day-to-day administration of the Trust shall be looked after by the Managing Trustee under the guidance control and supervision of the Board of Trustees.
 - ii. The Board of Trustees shall nominate one amongst the trustees as specified in para (5) above to be the Managing Trustee, who shall hold office for such period, as may be decided by the Board of Trustees.
 - iii. The managing Trustees shall perform all functions discharged such duties as or specifically entrusted to him/her in writing by the Board of Trustees.
9. **VACANCIES:** Any vacancy among the Members of the Board of trustees may be filled by the trustees as specified in para (5) above or their successors and they shall hold office for such duration as may be specified by the Board of Trustees.
10. **TERMINATION OF OFFICE OF THE TRUSTEES:** Trustee shall cease to hold office:
- i. if he dies,
 - ii. if he resigns,
 - iii. if he is adjudged insolvent or found guilty of an offence involving moral turpitude,
 - iv. if he is found to have acted against the interest of Trust,
 - v. if it is unanimously decided by the Trustees specified in para (5) above that his continuation in the office is against the interest of the Trust.

11. **MEETING AND PROCEEDINGS OF THE TRUSTEES:** The Trustees shall ordinarily meet once in three months or as often as may be necessary for the satisfactory conduct of the affairs of the Trust.
12. **NOTICE:** Seven day's notice shall ordinarily be given in writing for a meeting of Board of Trustees.
13. **QUORUM:** The Quorum for the Meeting of Board of Trustees shall be $\frac{2}{3}$ numbers quorum is required for a meeting adjoining for want of Quorum. A minute book shall be kept by the Managing Trustee. Minute of entry into the office every new trustee and of all proceedings of the meeting of the Board of trustee shall be entered in the minute book and shall be signed by the Chairman of the Meeting.
14. **VOTING:** Decisions of the Board of Trustees may be made at a meeting or by circulation of papers to them. Normal matters of routine nature may be circulated and decision obtained. The important are to be decided at the meeting. All matters arising for disposal shall be decided by a majority of the Board of Trustees present at the Meeting. The Chairman or the Board or Trustees shall have casting vote in the event of equality of votes, in addition to his own.
15. **THE BOARD OF TRUSTEES SHALL HAVE THE FOLLOWING POWERS:**
- i. To manage the properties assets and funds of the Trust, From time to time, such regulations (not being inconsistent with this deed) as they may think fit for and necessary for the purposes of such management and control or in connection with the execution of any of the subject herein contained powers hereby vested in them and may rescind or alter any such regulation.
 - ii. To accept donations, contributions, grants, subscription in cash or kind from any person company, firm, association, organization, government, non-government or semi government agencies, national or foreign funding agencies, family Trust or corporate bodies for furtherance and achievement of the objectives of the Trust.

- v. To appoint officers and members of staff for the Trust and to prescribe their condition of service.
- vi. To open and to provide for operating banking accounts.
- vii. To raise loans with or without security or to invite donation and financial help.
- viii. To receive the honorarium or salary against his/her services or involvement in any of the project or programme run by the Trust, which must be decided by the Board of Trustees and approved by the Chairman/Chairpersons.
- ix. To authorize person (s) to sign or execute document on behalf of the Trust.
- x. To grant receipts for aid or donation received.
- xi. To grant Special Power of Attorney to represent the Trustees in connection with any legal or other proceedings.
- xii. To acquire land or building on the lease or way of purchase.
- xiii. To compromise, compound or refer to Arbitration all actions, proceedings and disputes relating to Trust property or properties.
- xiv. To sell or give on rent /lease or on hire any immovable or moveable property of the Trust for some certain period (s) on such terms and conditions as the Trustees may think fit and proper from time to time.
- xv. To open any type of bank account(s) whether saving account, current account, fixed or otherwise, in the name of the Trust or Institution (s) or programme (s) run by the Trust with any scheduled banks (s) or post office (s) and to operate to authorize any person or persons, unless and until determined otherwise the such bank account(s) shall be opened and operated jointly with signature or any two members of Board of Trustees. The financial year for the Trust shall be from 1st April to 31st March and the accounts of Trust or institution (s) or programme(s) run by the Trust shall be audited yearly by the auditors b(s) or chartered accountant or a firm of chartered accountant to be appointed by the Board of Trustees and the fee for auditors(s), if paid, shall be a part of outgoing amounts from the Trust Fund.

- xvi. To give guarantee of the assets and property of the Trust , including the bank guarantee on behalf of the Trust to corporat bodies, persons ,firms, institution, as Trustees may decide from time to time . The trustees shall not be personally liable for such guarantees or the securities.
- xvii. To gifts, lease and transfer the immovable and moveable properties of the Trust.
- xviii. To appoint lawyer ,pleaders, advocated to file and defend suit or suits filed for and against the Trust and or in the name of the Trust and also file suits for financial and other disputes or dues with different parties and signed executed such application, petition document for such proceeding and delegate powers to the officers(s) ,employee(s) ,staff(s), and Trustee(s) for such proceeding (s) as required from time to time .
- xix. To appoint new member or members of Board of Trustee by a resolution and to discharged any of the Trustee, who become bankrupt or acts in any manner prejudicial to the interest or object of the Trust or is convicted of an offence involving moral turpitude or becomes of unsound mind or is otherwise unfit to continue as Trustee, by resolution passed by simple majority of members present and voting in the meeting of Board of Trustees.
- xx. To appoint from time to time on such terms and condition as they may determine a secretary, Manager, Executive Director ,Director(s) and other officer(s) or member(s) of staff for carrying out the activities of the trust and remove at ant time any such Secretary, Manager, Executive Director ,Director(s) and other officer(s) or member(s) of staff.

BANK ACCOUNT: (i) The board of Trustees may open such Bank Account or Account in any Bank in the name of ACHARYA RAMESH CHANDRA TRUST such accounts shall be jointly /singly operated by the Chairman and / or Managing Trustee.(ii) The Trust may open Bank Accounts in the name of Inscitution/organization founded by the Trust such Bank Account shall be operated by such persons as authorized by the board of trustees from time to time .

19. **DEFECTS OF PROCEDURE IMMATERIAL:** No act Trustee shall be invalidated by reason only of any vacancy in the Board of Trustees or any irregularity in the proceeding of the Board of Trustees or any committee thereof.
20. **AMENDMENTS:** Amendment will be made if required in Trust Deed which may be proved adverse for the provision of section 2(15), 11 ,12, and 13 and 80G of the Income Tax act, 1961 as amended from time to time.
21. **DISSOLUTION:** In the event of dissolution of winding up of the Trust the assets of the trust remaining on the date of dissolution shall under no circumstance be distributed among the Trustees, but the same shall transferred to other Trust Society, Association or Institution whose object are similar to those of this Trust.
