NOW THIS TRUST DEED WITHNESES AS FOLLOWS:-

- Name: The name of Trust shall be "ACHARYA RAMESH CHANDRA TRUST".
- 2. Place: That the registered office of the Trust shall be situated at Saket Nagar, Rupaidiha, Tehsil-Nanpara, District-Bahraich. UP, India or at such other place or places as the Board of Trustees may decide from time to time .Branch / administrative office can be opened in any part oh the country for the smooth functioning of Trust.
- 3. FUND: The board of Trustees shall hold a sum of () 100,000 (Rupees one lakh only) this day thereof which may hereinafter be received by the Board of Trustees from time to time as Gifts, Donations Grants, Subscriptions or otherwise for the purpose of the Trust and thr Trust fund shall vest in the Trustees jointly.
- 4. OBJECTIVE: That the objective of the Trust shall be wholly for the public and charitable purpose and incomes shall be applied for the same and accumulated in India wholly for public& charitable purpose without prejudice to generality fo provisions aforesaid and the following shall be deemed to be the principal objectives ACHARYA RAMESH CHNADRA TRUST.
- a) To establish Medical College , Engineering and Technology ,Polytechnic, Pharmacy college, Teacher's Training College, Management Institutes, Skill Development Training Centre and allied education institutions.

The trust shall be an irrevocable public educational, cultural trust for the benfit of all persons belonging to whatever community irrespective of Caste, Creed or Religion, the Trustees shall stand possessed of the said amount of corpus endwed by the Authors of the trust and such other properties(both movable immovable) as may be acquired from time to time by the Trust ,by purchase, exchange, grant, allotment, subscription, endowment, donation, contribution, or in any manner to whatsoever (all of which shall be designed as Trust properties) on the Trust ligrein mentioned.

- 5. NUMBER OF TRUSTEES: The number of Trustees including the settlers of the Trustees shall not be less than three and not more than seven persons. The Board of Trustees shall nominate and invite persons/persons to be other trustees for such period, as they may deem fit and proper.

- 7. CHAIRMAN: There shall be a chairman for the administration of this trust, nominated by the board of Trustees, who shall be one amongst trustees as specified in para (5) above to such period, in such manner as may be specified in this behalf.

3. MANAGING TRUSTEE:

- The day-Today administration of the Trust shall be looked after by the Managing Trustee under the guidance control and supervision of the Board of Trustees.
- ii. The Board of Trustees shall nominate one amongst the trustees as specified in para (5) above to be the Managing Trustee, who shall hold office for such period as may be decided by the Board of Trustees.
- iii. The managing Trustees shall perform all functions discharged such duties as or specifically entrusted to him/her in writing by the Board of Trustees.
- 9. VACANCIES: Any vacancy among the Members of the Board of trustees may be filled by the trustees as specified in para (5) above or their successors and they shall hold office foe such duration as may be specified by the Board of Trustees.
- 10. TERMINATION OF OFFICE OF THE TRUSTEES: Trustee shall cease to hold office:
 - if he dies,
 - II. if he resigns,
 - if he is adjudged insolvent or found guilty of an offence involving moral turpitude,
 - If he is found to have acted against the interest of Trust,
 - v. If it is unanimously decided by the Trustees specified in para (5) above that his continuation in the office is against the intrest of the Trust.

- 13. QUORUM: The Quorum for the Meeting of Board of Trustees shall be % numbers quorum is required for a meeting adjoining for want of Quorum. A minute book shall be kept by the Managing Trustee. Minute of entry into the office every new trustee and of all proceedings of the meeting of the 3 Board of trustee shall be entered in the minute book and shall be signed by the Chairman of the Meeting.
- 14. VOTING: Decisions of the Board of Trustees a=may be made at a meeting or by circulation of papers to them. Normal matters of routine nature mat be circulated and decision obtained. The important are to be decided at the meeting. All matters arising for disposal shall be decided by a majority of the Board of Trustees present at the Meeting. The Chairman or the Board or Trustees shall have casting vote in the event of equality of votes, in addition to his own.

xvi. To give guarantee of the assets and property of the Trust, including the bank guarantee on behalf of the Trust to carport borlies, persons, firms, institution, as Trustees may decide from time to time. The trustees shall not be personally liable for such guarantees or the securities.

xvii. To gifts, lease and transfer the immovable and moveable properties of the Trust.

xviii. To appoint lawyer pleaders, advocated to file and defend suit or suits filed for and against the Trust and or in the name of the Trust and also file suits for financial and other disputes or dues with different parties and signed executed such application, petition document for such proceeding and delegate powers to the officers(s) ,employee(s) ,staff(s), and Trustee(s) for such proceeding (s) as required from time to time.

xix. To appoint new member or members of Board of Trustee by a resolution and to discharged any of the Trustee, who become bankrupt or arts in any manner prejudicial to the interest or object of the Trust or is convicted of an offence involving moral turpitude or becomes of unsound mind or is otherwise unfit to continue as Trustee, by resolution passed by simple majority of members present and voting in the meeting of Board of Trustees.

To appoint from time to time on such terms and condition as they may determine a secretary, Manager, Executive Director Director(s) and other officer(s) or member(s) of staff for carrying out the activities of the trust and remove at ant time any such Secretary, Manager, Executive Director Director(s) and other officer(s) or member(s) of staff.

16. BANK ACCOUNT: (i) The board of Trustees may open such Bank Account or Account in any Bank in the name of ACHARYA RAMESH CHANDRA TRUST such accounts shall be jointly /singly operated by the Chairman and / or Managing Trustee.(ii) The Trust may open Bank Accounts in the name of Inscitution/organization founded by the Trust such Bank Account shall be operated by such persons as authorized by the board of trustees from time to time.

APPLICATION OF THE PROPERTIES OF THE TRUST: The properties and funds of the Trust shall be applied only for the purpose of the Trust and for the due administration of its business affairs and properties provided however that this shall not preclude payment of any remuneration or allowance or giving of residential accommodation or any perquisites to any trustee in connection with work carried out by him/her for the purpose of the Trust.
- 18. ACCOUNTS: The Trustee shall maintain a true and correct record of the receipts, payments incomes and expenses and transaction of the Trust. The book of account of the trust shall be audited by a qualified auditor or a Charted accountant every year i.e., commencing from 1st April to the 31st March of next year.
- 19. DEFECTS OF PROCEDURE IMMATERIAL: No act Trustee shall be invalidated by reason only of any vacancy in the Board of Trustees or any irregularity in the proceeding of the Board of Trustees or any committee thereof.
- 20. AMENDMENTS: Amendment will be made if required in Trust Deed which may be proved adverse for the provision of section 2(15), 11,12, and 13 and 80G of the income Tax act, 1961 as amended from time to time.
- 21. DISSLOTION: In the event of dissolution of winding up of the Trust the assets of the trust remaining on the date of dissolution shall under no circumstance be distributed among the Trustees, but the same shall transferred to other Trust Society, Association or Institution whose object are similar to those of this Trust.
