STATUTES AND REGULATIONS OF THE SOCIETY

10/1

1. NAME OF THE SOCIETY:
The name of the Society shall be
BATELA QWITABLE SOCIETY

2. MEMBERSHIP:
The membership of the Society is open to any person or persons of villages, colonies, who has attend the age of majority and abide by the terms and conditions of the society, without description of the religion, cast, colour, creed but subject to the approval of the Governing body.

3. MEMBERSHIP FEE:
The rate of subscription for all the member shall be rates Rs. 100/- per month and admission fee Rs. 100/-

4. APPEAL:
The governing body of the Society may refuse any person for the membership, provided reason for refusal shall be communicated to the person concerned in writing with reason.

5. REVISIONS:
The governing body of the Society may appeal any member from the following grounds:-

- a) On his/her death.
- b) If the member fails to pay the timely subscription, continuously for three months from the date of the paying the subscription.
- c) If the member works against the aims of the Society.
- d) If the member shows his/her resignation.
- e) If the member fails in the meeting of General Body and governing body.

The reason of the revocation shall be submit to every member every year expelled members shall have a right to appeal before the General Body which may or may not accepted.

APPEALS:

All the appeal shall preferred to the General Body of the Society, the Decision of the General Body shall be final.

The reason for rejection shall be communicated to the member concerned including the officer Secretary. The meeting of the Governing Body shall be held after every two/three months required in the adjourned meeting. An exceptional meeting of governing body may also be convene on the written request of three/five by then 10 day notice of the meeting.

7. RE-ADMISSION:

That members of member expelled by the General Body the same can be re-admitted provided the member concerned, pays, all arrears dues. The Decision of the General Body shall be final.

8. RIGHTS AND PRIVILEGES OF THE MEMBER:

There every member shall have right to participate in the General Body meeting and shall also be entitled to inspect record of the society which prior approval of Governing Body, decided his/her shall have also right to vote in the meetings of the society every members shall be entitled to participate, in the meetings functions and get together programs of the society pertaining to any matter of the society.

9. GENERAL BODY:

There shall be General Body of the Society consisting of all the member. The meeting of its General Body shall be held after every three months. The Quorum for Quorum shall be required in the adjourned and meeting adjourned meeting of the general body may also be convened on the written request of 10 days with prior notice for such members/meetings. OFFICE BEARERS AND THEIR DUTIES

- a) PRESIDENT: Mr. [Name]
