"RULES AND REGULATIONS OF THE SOCIETY"

1. NAME OF THE SOCIETY:
The name of the Society shall be
" SATILILA CHARITABLE SOCIETY "

2. MEMBERSHIP:
The membership of the society is open to any person or persons of villages, colonies, wh. has attend the age of majority and abide by the terms and conditions of the society, without descriptions of the religion, cast, colour, creed but subject to the approval of the Governing Body.

3. SUBSCRIPTION:
The rate of subscription for all the member shall be rates Rs. 100/- per month and admission fee Rs. 100/-

4. REFUSAL:
The governing body of the society may refuse any person for the membership, provided reason for refusal shall be communicated to who person concerned in writing with reason.

5. EXEPTION:
The governing body of the society may expel any member from the society on the following grounds:-
 - a) On his/her death;
 - b) If the member fails to pay the timely subscription, continuously for three months from the due date of the paying the subscription.
 - c) If the member works against the Aims of the Society.
 - d) If the member tenders his/her resignations.
 - e) If the member fails three meeting of General Body and governing Body.

The reason of the execution shall communicate to every member every such expelled members shall have a right to appeal before the General Body which may or may not accepted.

6. APPEALS:

All the appeal shall preferred to the General Body of the Society, the decision of the General Body shall be final.

The reason for rejection shall be communicated to the member concerned including the officer bearers. The meeting of the Governing Body shall be held after every two/three quorum required in the adjourned meeting. An emergent meeting of governing body may also be summon on the written request of three/five by them 10 das notice of the meeting.

7. RE-ADMISSION:

That increase of member expelled by the General Body the same can be re-admitted provided the member concerned, pays, all upto-date dues. The decision of the General Body shall be final.

8. RIGHTS AND PRIVILEGES OF THE MEMBER:

There every member shall have right to participate in the General Body meeting and shall also be entitle to inspect record of the society which prior approval of Governing Body, decided his/her shall have also right to vote in the meetings of the society every members shall be entitled to participate, in the meetings functions and get together programs of the society pertaining to any matter of the society.

9. GENERAL BODY:

There shall be General Body of the Society consisting of all the member. The meeting of the General Body shall be held after every three months. The Quorum no Quorum shall be required in the adjourned and meeting emergent meeting of the general body may also be summoned on the written request of 10 days with prior notice for such members/meetings. The notice period of General Body shall such meeting. The following business shall be given as urder:-

- a) To prepare annual programs and policies.
- b) To discuss and to decide all such other later and issue which are directly and indirectly related to the affairs of the society.
- c) To pass annual project of society.
- d) To appoint a qualified auditor who will all audit the account of the society.
- e) To consider any business brought for way by the Governing Body.
- f) All the meeting of the General Body shall be summoned by the General Secretary.

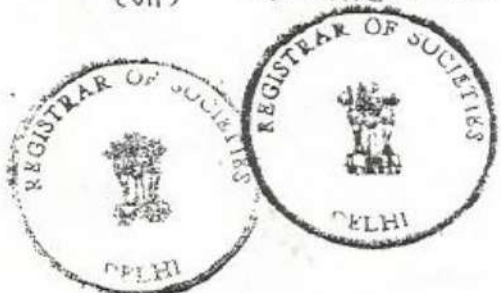

He shall assist in the day work of the society as a directed by the president and General Secretary.

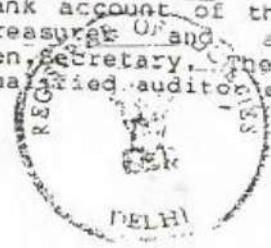
12. REGISTER OF MEMBERS:


