## **Board Resolution**

#### "RESOLVED"

That the society runs a college named 'BHAGWATI INSTITUTE OF TECHNOLOGY AND SCIENCE' at Masuri, Ghaziabad, Uttar Pradesh.

That in view of the changing demand of Courses it is decided that following changes will be made in the exiting intake of the college in accordance with the motto of the society.

#### 1. INCREASE IN INTAKE

- a. B.Tech Computer Science and Engineering from 60 seats to 120 seats
- b. Master of Computer Applications (MCA) from 120 seats to 180 seats

#### 2. INTRODUCTION OF NEW COURSE

a. Polytechnic – Computer Science and Engineering with 60 seats

#### 3. REDUCTION IN INTAKE

- a. B.Tech Civil Engineering from 60 seats to 30 seats
- b. B.Tech CSE (Artificial Intelligence and Machine Learning) from 60 seats to 30 seats
- Polytechnic Civil Engineering from 60 seats to 30 seats
- d. Polytechnic Mechanical Engineering from 60 seats to 30 seats

Further it was resolved that in view of Judgement dated 28.03.2023 of Hon'ble Delhi Hight Court in Copyright Infringement Case Co. (Comm) No 96 of 2023 between Birla Institute of Technology and Science, Pilani VS Bhagwati Institute of Technology and Science, Ghaziabad the society has already stopped using the acronym BITS for its college Bhagwati Institute of Technology and Science, Ghaziabad; but still students. staff and various third parties continue to refer to the college with the acronym BITS, which may account to violation of order passed by Hon'ble High Court and may lead to further litigation. Hence the society has decided to change the name of the Institute. The new name of the institute which was approved by the board shall be "JMS INSTITUTE OF TECHNOLOGY" in short JMSIT.

That the Governing Body has unanimously resolved that Mr. Himanshu Singhal, Secretary of the Society is hereby authorized take up the cause with AICTE, New Delhi and AKTU & BTE Lucknow and other authorities to execute / sign / submit necessary documents etc. required by concerned authorities.
