

5. That the facts stated in this affidavit are true to my knowledge. No part of the same is false and no material has been concealed there from.



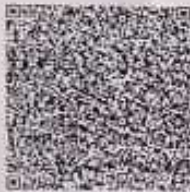
