'Rules" mean the Rules and Regulations of the society for the time being in force.

"General Secretary" means the General Secretary holding office as such.

CONSTITUTION OF THE SOCIETY

The Society is established for the purpose, and with the objectives specified in the Memorandum of Association.

The persons who are and who have signed the Memorandum of Association shall be the founder members of the society shall construct "JAI MAA SAVITRI EDUCATIONAL SOCIETY"

The General Body (G.B.) shall combin of all the topoder members of the society and the whole life members admitted by the society in matter. The G.B., will hold a meetings every five years to elect the Governing body of the (... et) out of its G.B. members. On completion of one year from the constitution of the Society, the governing body shall be elected for a term of five years with the consent of at least 167% of the members with voting rights of all the members of the G.B. All the founder members have the right to become chairman of the society for one term of five years in one term of the Governing Body of the Society. Any G.B. member can renounces his right of becoming Chairman in favour of any other member. In case, a member renounce his right, then that member will not be eligible to become Chairman of the Society in that tenure of it: Governing Body unless any other member renounce his right of Chairmanship to his far out. A member shall not hold the office of the Chairman continuously for more than three terms on the basis of renunciation of right by other member. All the members shall have the right to become Chairman for one teen of five years. If any new member is added in the society, the new member will become etigible for chairmanship from the next tenure of five years only. The other rules for renonciation of right, and continuous holding of chairmanship shall remain the same. This clause can be changed of swith the consent of 6 whole life member.

And person will be eligible to become a member of the society. Every candidate for admission as a member shall be proposed by one and seconded by enother member. The application for membership shall be made in vising on a prescribed form and shall contain such fractulars as may be prescribed duly signed by the candidate, his proposer and meganicity and shall be delivered to the General Secretary/Secretary together with the amount of superior as provided in places. We the Sules and Regulations of the society.

The G.B. may, at its discretion either admit of reject any candidate for membership of the society and shall not be bound to give reason for the rejection of any such considere. The membership shall be decised to have been a proceed if six the G.B. members approve such application for membership.

On admission of a mention the G.B. shall notice the date of admission.

Every member after joining the society will undertake that so long as he shell combine to be a member he will follow the roles of the society architected from time to time.
