- H) To arrange for mental and physical recreation of the financially lesser able persons by holding sports and games, competitions, arranging film shows and organising dramatic activities.
- I) To publish Journals, Periodicals and Books with an effort to enlighten the mankind.
- J) To send and receive members abroad in order to spread our cultural achievements and adopt what is better in our counter parts.
- K) To grant scholarships, bursaries, freeships, annuities and other grants to the needy and poor.
- L) To takeover, manage or combine, whether by affiliation or otherwise, with any other Institution for the furtherance of all or any of its objects.
