- i) as per the procedure in vogue, the institution applies in SIF for number of seats per specialization / raise in admission in case number of seats sanctioned by PCI are less than 15.
- v)In view of above statutory provisions of the M.Pharm Regulations, it was decided that in case institution has the prescribed teaching staff with prescribed experience as per "The Master of Pharmacy (M.Pharm) Course Regulations, 2014", PCI shall sanction number of admissions per M.Pharm specialization based on availability of the teaching staff irrespective of institution's request in SIF. However, under no circumstances more than 15 students per specialization shall be sanctioned.
