 - c) They shall produce records of their legal entity and the land and building documents to substantiate their claims.
 - d) Wherever needed inspections will be carried out subsequently and if the facts claimed by the institution are found false, the PCI may change or withdraw the approval.
 - e) Any approval granted by the PCI beyond 2021-2022 academic session will stand but will be considered year on year basis based on the information submitted by institution in online SIF.
 - f) Wherever required, institution shall furnish additional information as sought by the PCI from time to time.
 - g) The request for raise in admissions for D.Pharm course beyond 60 intake is not considered as per the policy of the council.
 - h) Regarding M.Pharm seats, it was noted that 110 Central Council in its meeting held on 11th December, 2020 under item No.273 decided as under
 - i) 12 specialties / subjects are prescribed in which M.Pharm can be conducted. (Ref: Reguation-9., Appendix-A of M.Pharm Regulations).
 - ii) maximum 15 seats per specialization are sanctioned by PCI (Ref: Regulation-23.(1) of M.Pharm Regulations)

Further as per the statutory provisions of M.Pharm Regulations, the ratio of recognized Post-Graduate teacher to number of students to be admitted for the M.Pharm course shall be 1:3.

- iii) as per the procedure in vogue, the institution applies in SIF for number of seats per specialization / raise in admission in case number of seats sanctioned by PCI are less than 15.
