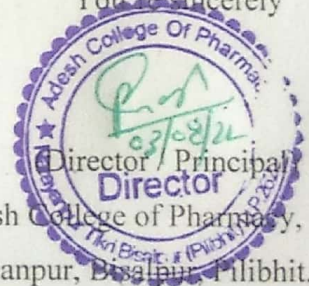
Respected Sir,

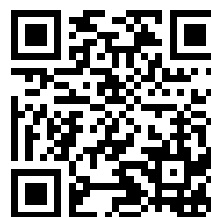
