In case any change is observed, the same will not be entertained at any cost and the liabilities will rest only with the Institute and NOT PCI. 'c) the above decision is subject to verification of compliance by the PCI at any later date and if compliance is found false, PCI will initiate action for withdrawal of approval u/s 13(1) of the Pharmacy Act, 1948 and consequences thereof and responsibility will rest on			

the institution alone.
