With reference to the subject cited above. I am directed to convey the decisions of 396<sup>th</sup> Executive Committee of the PCI held on 1.6.2023, which decided as under –

<p>Madhu Vachaspati Institute Of Pharmacy, 0, Rasoolabad Urf Koilaha, Puramufti, G.T.Road, Kaushambi, 212213, Uttar Pradesh</p> <p>PCI-3271</p>	<p><i>The 396th EC held on 1.6.2023 has decided to review its decisions taken in 393rd EC (19.4.2023) and 395th EC (11.5.2023) in accordance with the order dt.12.4.2023 in WP No. 4463 of 2023 and other connected matters passed by the Hon'ble High Court of Delhi. The matter was discussed at length and after the due deliberation and considering the inspection report placed before the Executive Committee, it was resolved that</i></p> <p>"The deficiencies pointed out in the earlier inspection stands rectified, however as the additional deficiencies pointed out in the latest inspection could not be taken into account, therefore the Institute is granted permission for the Academic Year 2023-24, however subject to the Principal of the Institution submitting an undertaking on an affidavit within 15 days to the effect that the deficiencies pointed out in the latest inspection stands rectified. Upon submission of the undertaking on affidavit the Institution may be re-inspected later on and the institution would be required to submit compliance in respect of all the deficiencies and the permission for next academic year would be given only if all the deficiencies gets rectified."</p> <p><b>Deficiencies:</b></p> <ol style="list-style-type: none"><li>1. Exhaust Fan in Pharmacognosy Lab is missing.</li><li>2. Balance room not available</li></ol> <p><b>D.Pharm</b> Extend approval upto 2023-2024 academic session for 60 admissions for D.Pharm course.</p>

The last approval for 2022-23 academic session is restored and vide notification dt. 22.10.2022 read with 3.11.2022 instructed the institutions to submit affidavit.

In view of above, it was decided to verify the said affidavit during the inspection process of 2023-2024 academic session.

Regarding introduction of new B.Pharm course –  
Grant approval for 2023-2024 academic session for 60 admissions for the conduct of 1<sup>st</sup> year B.Pharm course followed by inspection during the year.
