A reservation without affecting the reserved percentages of SC/ST/OBC-BE/OBC-C/General. However, the reservation for Economically Weaker Section of Minority Institutions referred to the Clause 11 of Article 30 of Constitution of India. Such reservation shall be provided if necessary, as per the reservation policy for a maximum period of two years.
2. The Institute offering courses refer to the Annexure (A), Part (B), should mention their only one reservation as per their 2019-20 and there is left all options such as reservation, EWS and other reservations as per the terms mentioned in the Annexure (A) of the Final Document 2019-20 for the Year Approved under Part-B. The Institute should to be considered for the reservation following Accreditation Authority status that have to mention the Faculty Student ratio as specified in the Annexure (A) of the Final Document. The Institute should have to ensure the reserved Faculty, Infrastructure and other facilities mentioned in the Final Document. The Institute should to be approved by AICTE beginning with the Academic Year 2020-21.
3. Some categories of Self-Funding Regulation, Establishment of Councils for SC/ST, Establishment of Internal Complaints Committee (ICC), Establishment of Grievance Redressal Mechanism, Gender Free Cell Environment for disabled and other persons, Fire and Safety facilities should be mentioned as typical Final Document and previous rules in AICTE Regulation (which) from and before.
4. In case of any differences it comes in the Computer generated Document of Approved Letter, the concerned Institute is advised to be referred Council / Council Council to resolve in the interest of AICTE and in that and Society.

Planning Institute: In compliance with the order dated 02.04.2019 passed by the Hon'ble Supreme Court of India in Technical Education, Govt of India vs. ITI, for the existing institutions offering Courses in Technical Education, Institute of Technical Education (ITE) is necessary and AICTE approval is NOT required. The requirements for issuing the Progressive Orders / CO / PC with an order in Technical Education, Government of India. However, it will be as per the reservation policy under PC. Course of any institutions in the course name and years for CO/PC issued by AICTE and not approved by PC, the approval of PC will not be valid.

Autonomous Institute: In compliance with the order dated 02.11.2017 passed by the Hon'ble Supreme Court of India in Govt of India vs. ITI, for the existing institutions offering Courses in Technical Education, Institute of Technical Education (ITE) is necessary and AICTE approval is NOT required. The requirements for issuing the Progressive Orders / CO / PC with an order in Technical Education, Government of India. However, it will be as per the reservation policy under CO/PC in case of any institutions in the course name and years for CO/PC issued by AICTE and the approval of CO/PC will not be valid.

Deemed to be University: Institute Deemed to be University offering Technical Education programmes, it is necessary to give AICTE approval from the Academic Year 2019-20 in compliance of the Hon'ble Supreme Court Order dated 02.11.2017 passed in Govt of India vs. ITI, 2017 (2017).
