We are pleased to offer you appointment as **Principal** in **Yogendra Nath Saxena College of Pharmacy and Research Centre Hasanpur Distt Amroha U.P.** on the recommendation of duly constituted selection committee. You will be place on a scale of Rs. 37400-67000, GP 10000.

The terms & conditions of your appointment will be as under:

1 Service Conditions:

- (i) You will be governed by service conditions as per Institutions Byelaws, framed from time to time. You are required to abide by the Rules & Regulations of the Institute/AKTU/AICTE, as applicable.
- (ii) You shall not indulge in any tuition/coaching/any employment outside the Institute.
- (iii) No Institute employee who has a spouse living shall contract another marriage, notwithstanding that such subsequent marriage is permissible under the Personal Law for the time being applicable to him/her. The minimum punishment to be imposed for contravention of this condition above shall be removal from service.
- (iv) You will be required to take an oath of allegiance to India and Constitution of India as by Law established.
- (v) You shall carryout such duties as assigned by the management of **Yogendra Nath Saxena College of Pharmacy and Research Centre, Hasanpur, Distt Amroha, U.P.**
- (vi) In case of your being found guilty of misconduct, violation of the code of conduct and discipline of the Institute or any of the conditions of the appointment, your

service can be terminated forthwith without any notice or compensation, in lieu thereof, whatsoever.

2. **Termination of Service:** Your appointment may be liable to termination on one month's notice from either side or pay and allowance in lieu thereof but the Institute will not pay any salary if notice of resignation is given by you in the months of May to August, and that you may be relieved at any time at the convenience of the Institute. Further, if you resign during the semester, you will only be relieved at the end of the semester.
3. **Medical Certificate:** You are required to submit a medical certificate of fitness from a medical officer not below the rank of Chief Medical Officer.
4. **Travelling Allowance:** No traveling allowance will be paid for joining or relinquishing the post.
5. **General:**
 - (i) If the offer is acceptable to you please, join your duties on or before 02nd September, 2019, or earlier, failing which the offer may stand cancelled.
 - (ii) Please bring all your original credentials at the time of joining alongwith one photocopy of each and two passport size photographs and aadhar card.
