Dear Mr. Uma Shanker Maurya,

With reference to your application for faculty position in our Institute and subsequent interview held on 14.05.2011, as per the authorization & approval of the Chairman S.C.G. given to me. 2. Suitable residential quarter rent free shall be provided to you in Sherwood Educational Campus, Barabanki as per requirement of the Institution.
3. The term and conditions for the service post offered to you have been explained in detail at the time of interview.
4. Your ad-hoc appointment can be terminated any time by issuing one month notice or one month salary on either side. However, you will not be relieved from the institute during the mid semester.
5. Your service can be terminated at any time without notice during this period of ad-hoc appointment in case of misconduct or misbehavior or any act which is against the institute. Your absence from duty continuously for more than five days without any information will be considered as resignation from the service.
6. You will be reporting to the Director, SCP and will act as per his directives and also as per the policies of the management from time to time.
7. You will not leave the Institute in mid term and you should surrender one of your original certificates to us, which shall be given to you at the time of proper leaving.
8. You will not apply in any other Institution without the prior permission of the management.
9. Your appointment is effective from 20/07/2011.
