- After completion of satisfactory probation period, this appointment can be terminated on one month notice from either side, or payment in lieu thereof.
- In addition to your regular job, you will undertake to participate in and perform such further duties that the chairman / director may assign from time to time like arrangement of and participation in meetings, conferences and other activities you will discharge your duties diligently and efficiently to the best of your ability and to the satisfaction of management.
- You shall solely serve the Institute and will not seek employment / part time work anywhere else whether gainful or otherwise without express sanction of the Management.

- You shall maintain confidentiality of all knowledge gained during your employment and shall not divulge the same to any unauthorized person by word or deed or otherwise at any time.
