Mr. Rohit Singh , M.Pharm , Ph D (pursuing) is hereby appointed as Assistant Professor in the Department of Pharmaceutical Chemistry at College of Pharmacy, JSS Academy of Technical Education, Noida purely on temporary basis with a pay of `50,000/- PM for period of two years. After completion of two years of service he will get the pay scale of `15600-39100+AGP 8000'(Subject to review of performance) with other admissible allowances as per the rules, with effect from the date he reports for duty.

THIS APPOINTMENT IS MADE SUBJECT TO THE FOLLOWING CONDITIONS.

1. He / She will be on probation for a period of two years.
2. This appointment is purely temporary and is terminable with one month's notice on either side or on payment of one month's salary in lieu of one month's notice during the probationary period.
3. After satisfactory completion of probationary period the appointment is terminable with three months' notice or three month's salary in lieu of notice on either side.
4. In addition to the above, he / she should fulfill the following conditions also while discharging his / her duties.
 - a. The incumbent shall actively involve in teaching and patient care as applicable and other work entrusted to him/her by his/her reporting authority from time to time.
 - b. On successful completion of the probationary period and before declaring the same he / she will be evaluated for –
 - i. Research work done / initiated by him / her.
 - ii. Publication made.
 - iii. Participation in additional curricular and Co-curricular activities.
 - c. He / She shall not engage in private consultancy which is of conflict of interest with the Institution.
 - d. In the event of his / her setting of / partnering / supporting / promoting other business activities etc. and has conflict of interest with the Institution his / her services will be terminable with one month's notice.
 - e. He / She shall be bound by the Pharmacy ethics and if observed to have violated the same shall be liable to suitable action as per rules.
 - f. If during the working hours of the Institution is found to be absent (or) engaged in professional practice without the prior knowledge of the competent authority, the same will be considered as dereliction of duty and suitable action will be taken.

The Principal has to obtain an undertaking covering the above points from (a) to (f) from the above candidate at the time of her reporting for duty.

He is directed to report for duty to the Principal, College of Pharmacy, JSS Academy of Technical Education (JSS ATE), Noida forthwith.
