Responsibilities:-

- 01. You will be responsible to report to Director (Pharmacy) of the Institute.
- 02. You will act within the framework of the organizational structure and policies and directions as may be laid down by the Management from time to time.
- 03. All matters pertaining to your appointment and compensation are strictly confidential and it should be treated as such.
- 04. Your acts shall be solely for the development of your department and students.
- 05. You will participate in solving the administrative problems and also encourage students in all the development activities.

Other terms and conditions:-

- 01. You will be on probation for a period of one year and your service may be discontinued either by the Management or by yourself without assigning any reason on either side.
