NOTIFICATION : APPOINTMENT

In continuation of this Office order No. IU/RO/GA/2008/01, dated: 30.01.2008 the services of **Mr. Anoop Kumar Sirbaisya, Assistant Professor, Faculty of Pharmacy**, on the recommendation of Selection Committee held on 13.03.2010, are hereby regularized w.e.f. 13.03.2010 in the pay scale of Rs.15600-39100 alongwith other allowances as applicable in the University on the following terms and condition :-

1. That his services can be terminated by proper notice by either side, the period of which shall be three months or salary thereof in lieu of the whole notice period. However, he can be relieved only on the closure of the Semester so that no academic progress is hampered.
2. That his service conditions shall be governed by the provisions of the Integral University Act, 2004 or the Statutes framed there under and other rules, regulations, Ordinance or orders framed or issued under the said Act and the Statutes.
3. That he will work sincerely and diligently and will not indulge in any activity subversive of law and order to the best interest of the University.
4. That this appointment shall be liable to be cancelled or terminated at any stage, in case any information supplied by him in his application form or otherwise is found to be false, misleading or incorrect.
5. In addition to his normal duties, he will have to perform other administrative responsibilities of the University/Department also, if assigned to him from time to time.
6. That he will not indulge in any type of private tuition or coaching either of any student of this University or of any other institution whatsoever it may be, without the permission of the Vice Chancellor. He will not engage himself directly or indirectly in any other business/profession/employment (part-time) during the continuation of his above employment in this University.
7. That he will be required to deposit an amount of Rs.25,000/- (Rupees Twenty Five Thousand only) against F.D.R. in the joint name of the candidate and the Treasurer, Integral University, Lucknow, towards security money, within two months from the receipt of this letter positively, which shall be refunded to him alongwith the interest after clearing all the dues properly at the time of his retirement / cessation of his employment from the University.
