## ORDER OF APPOINTMENT

With reference to the application of **MRS. 1. That she will be paid a salary as per Sixth Pay Scale 37400 Basic + 9000 AGP + 8600 Allowances per month.
2. Her services will be governed by the Rules & Regulations of Krishna Institute of Pharmacy and Sciences, Kanpur.
3. That her payment of salary shall be subject to deduction of TDS, as per the Income Tax Act.
4. That in case she is found to be irregular, in disciplined and negligent towards the duties assigned, her services shall be terminated without any notice.
5. That her appointment will be on Probation for a period of one year from the date of her joining. During the Probation period, if, her services are not found to be satisfactory, her services can be terminated at any time without notice.
6. If, she is involved in activities subversive of law, her appointment may be terminated without any notice.
7. That in addition to her own duties of the post appointed for, she will look after any other work, assigned to her from time to time in the interest of the Organization.
8. That she will have to remain devoted, diligent, faithful and discharge her duties of the post to which she has been appointed sincerely and honestly.
9. That at the time of reporting for duty, she will have to submit copies of all relevant certificates & testimonials alongwith four copies of recent Passport size photographs.
10. She will not be allowed to resign in mid semester seeing student welfare. If she resigns in mid semester, in this case, she will not be entitled for the salary of same month.

If, the terms & conditions of the appointment are acceptable to her, **MRS. NEELOTTAMA KUSHWAHA** may report to the Principal of the Institute to join the duties within a month. If she does not join the duties within the stipulated time, it will be presumed that she is not interested to join and her appointment will stand cancelled without any further communication to her.
