- You will be on probation for a period of one year. aì
- b) During the probation period you will be placed in the consolidated salary of Rs. 25,000/-(Rupees twenty-five thousand
- You are advised to report for duty on or before 01.10.2022 c)
- Your services are transferable anywhere in the interest of the institute.
- In addition to your regular duties, you may be assigned any other duty in the interest of the institute. You will also assist e) in the admission of the students to this institute. Ð
- You are not permitted to leave during academic sessions. In case you leave, you will have to pay one month's salary. In case the college asks you to leave, the college will pay one month's salary to you. g)
- In case you are terminated due to legal action/in-disciplinary act, the college is not liable to make any payment.
- h) Policy for resignation and termination is as under: -
 - One month's notice must be served from either side. 1.
 - 30th of June/31st of Dec are the final/last dates of serving the organization after resignation or н. termination.
 - A person who is resigning should inform latest by 31" May/30th Nov. Similarly, college will inform a ш. person to be terminated by 31st May/30th Nov. That gives one month's notice period. If no resignation has been received during this period, it will be considered your willingness to continue in the job. Leaving after this period will automatically invoke clause no. (f). Also, you have to deposit one month's salary as security to avoid sudden departure without notice. This may be deposited in two installments.
 - One-month security money will be returned back at the time of leaving/termination after completion IV. of no dues.
 - A person may avail of all his pending leaves during the notice period. V.
 - i) All the terms and conditions regarding your job, service rules, and code of conduct in Bhanmati Smarak of Pharmacy will be as per the bye-laws of the trust and rules framed from time to time and will be binding upon you.
