
OFFER/ APPOINTMENT LETTER

3. As a full time employee, will not engage yourself in any other employment outside the institute and you are required to abide by the rules and regulation of the institution in letter and spirit in applicable. All fixed time to time other terms and conditions including service rules will be provided to you separately.
4. Your services are transferable to anywhere in the interest of the institution.

8. Casual leaves- one day on each completed month of service during first year of service or 12 days in a year in subsequent years.

10. Sick leave 2 day in a year however during first year of service it is payable on pro-rata basis the sick leave payable on half pay. At source of deduction of income Tax will be made on salary as per the Income Tax Rules.
