OFFER/ADJOURNMENT LETTER



1. The nature of your appointment is regular basis.
2. This appointment can be terminated at any time without any notice as per the bye-laws of the institution.
3. As a full time employee, you will receive gratuity in the usual arrangement subject to the condition and you are required to abide by the rules and regulations of the institution as given and apply as applicable and would have to forego other forms and conditions including service rules will be provided to you separately.
4. Your services are transferrable to anywhere in the interest of the institution.
5. In case of your being found guilty of misconduct or violation of any the conditions of appointment including the code of conduct and discipline of the institution, your services can be terminated without any notice or compensation in the law of that what is over.

11. You will be entitled a furnished accommodation if and when available in the campus. During this period you will be paid the monthly salary 25000 as per norms of BTE/PCU/UP Government /BTE/Trust rules.
