With reference to your application and subsequent interview held on 13/01/2021 the management committee is pleased to appoint you on the post of Principal in the Shree Thakur J Pharmacy College, Ghadpar on basic pay 4500-8800 (with AWP 6,000) on the following terms and conditions:

1. The nature of your appointment is regular basis.
2. This appointment can be terminated on one-month notice from either side, on payment in lieu of notice.
3. As a full time employee, will not engage yourself in any other employment outside the Institute and you are required to abide by the rules and regulations of the Institute in letter and spirit as applicable and issued time to time. Other terms and conditions including service rules will be provided to you separately.
4. Your service are transferable to anywhere in the interest of the first job.
5. In case of your being found guilty of misconduct or violation of any the conditions of appointment including the code of conduct and discipline of the Institute, your service can be terminated forthwith without any notice or compensation with the lieu of what is given.
6. In addition to your regular duties you may be assigned any other duty in the interest of College. You will also assist in admission of the students for the Institute.
7. During the period of engagement the types of leave may be sanctioned to you.
  - a. Casual leave - one day on each completed month of service during first year of service or 12 day in a year in subsequent year.
  - b. Earned leave P.L. one day for P.L. will be accrued and credited in your account on the rate of one day on completion of each 11 day working. The first accrual will be made after 11 months of continuous service.
  - c. Sick leave - 15 days in year however during first year of service it is payable on pro-rata basis. The sick leave payable on half pay. All manner of deduction of Income Tax will be made as salary as per the Income Tax Rules.
8. You will be allowed a furnished accommodation if and when available in the campus. During this period you will be paid the monthly salary as per norms of AICTE/UP Government/BTE/Tram rule.
9. This offer of appointment letter is purely temporary subject to approval of state Govt. and concerned approval bodies with a probation period of one year.

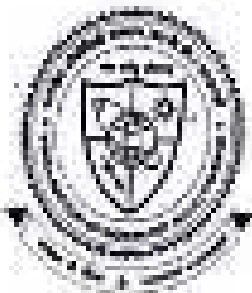
