## APPOINTMENT ORDER

On the basis of interview held and recommendation of selection committee I am pleased to appoint Mr. Vinay Kumar As an Lecturer in department of Pharmacy in scale of 15600-39100 + AGP on following terms and conditions:

- 1-He will be on probation for a period 2Years, which shall be extended upon the discretion of appointing authority, even after completion or before the prescribed period of 2 years. The probation period could be extended by such period as may be decided by the appointing authority.
- 2-The regularization of the probation would be depend upon the suitability of his work performance during the period of probation or if extension thereof. The decision of the appointing authority on the suitability of confirmation/probation shall be final and binding. There is no right with person to be confirmed on completion of probation.
- 3-The appointment is subjected to rule, Byelaws and regulations of Shri Krishna Technological Research and Development Charitable trust, Prayagraj (UP) as well as N.K. College of Pharmacy Prayagraj (UP) and they will be binding on him.
- 4-He will not be allowed to leave the job during the academic year. He will have to get NOC from N.K. College of Pharmacy Prayagraj (UP) for applying to any other job.
- 5-He will have to submit the proof regarding his Date of Birth, Educational Qualifications, Two passport size Photograph, Physical Fitness Certificate from an approved registered medical practitioners.
- 6- He continuous unauthorized absence from the duty will lead to termination of his services from the date of absence.
- 7-He will be under the disciplinary control of the Principal, N.K. College of Pharmacy Prayagraj (UP).His duties and assignment will be fixed by the Chairman/director/Principal.
- 8-He is requested to join immediately and will submit his joining report to the Director/Principal, N.K. College of Pharmacy Prayagraj (UP) on the 1<sup>st</sup> day of joining the duties.
- 9-The N.K. College of Pharmacy Prayagraj (UP) reserves the right to terminate your services without assigning any reason.
- 10-Service can be terminated without assigning any reason by giving 1 month salary/notice during the probation period and three month salary/notice after the conformation.
- 11-He can resign from the services by giving 1 month salary/notice during the probation period and 3 month salary/notice after the confirmation.
- 12-He will not be allowed to join/conduct coaching without prior permission of the appointment authority.
- 15-On joining the candidate will submit a bond prescribed by the N.K. College of Pharmacy Prayagraj (UP) on Rs.50/-non-judicial stamp paper.
