6. You shall maintain confidentiality of all knowledge gained during your employment and shall not divulge the same to any unauthorized person by word of mouth or otherwise, at any time.
7. You shall use every care in respect of Institute property, goods or cash in your charge and shall render an account of the same when called upon to do so.
8. If at any time in the opinion of the Management, which is final in this matter, you are found guilty of dishonesty, disobedience, disorderly behavior, negligence, indiscipline, absence from duty without permission or any other conduct considered by the management to be detrimental to the interest of the Institute, or by violation of any terms of this letter, your services are liable to be terminated forthwith, without notice or one month's salary in lieu thereof.
9. Your appointment is based on the information given by you in your bio-data. If at any time the information given is found to be incorrect or concealed, your services shall be terminated with immediate effect without giving any notice or salary in lieu thereof.
10. If at any time you wish to discontinue the services you shall serve a notice of one month ensuring that your last working day does not fall during mid-session and continue to perform your duty with full sincerity and diligence during this period.
11. If at any time you wish to leave the Institute, then after resignation the accounts shall be finalized after the submission of no dues certificate and all clearances from concerned departments which have to be submitted within 10 days of your date of resignation after which no claims of any sort will be entertained.
