- 1. This appointment is effective from <u>Jr/c9/2623</u> the date of your joining our Organization.
- Your salary and other allowances shall be as per norms.
- 3. Your job functions and responsibilities as Assi Professor are under preparation and shall be issued in due course.
- 4. You will be placed on probation for a period of Eleven months and the said period can be extended by another three months and on the expiry of the period of probation or extended period of probation, if you are not confirmed in writing, your services shall be deemed to be automatically terminated. However, unless you are confirmed in writing, you shall not be deemed to be permanent.
- During probation, the notice period for termination will be 24 hours from either side. After confirmation, the notice period required from either side is Three month.
- 6. After successful completion of your probation, you will be confirmed in writing as a permanent employee of the Organization. You will be entitled to statutory and service benefits and be governed by discipline and other rules existing or may come into existence from time to time, as and when

- applicable as per rules of the Organization and such other benefits as applicable to employees in force from time to time to the location / place wherever you are working.
- 7. Your future increments or promotion or any other salary increase shall be based on merit considering your periodic and consistent overall performance.
- 8. You shall retire from the services of the Organization on attaining 63 years of age. Your date of birth for the purpose of Organization's record is entered as __26_100|1998_ as per Xerox copy of __High_School-__ Certificate submitted by you.
- 9. During the tenure of your services, you will wholly devote yourself to the work assigned to you and will not undertake any other employment either on full or part time basis without prior permission of the Organization in writing. Any contravention of this condition will entail termination of your services from the Organization.
- 10 In the event you are absent from duty without information or permission of leave or you overstay your sanctioned leave, the Management will treat you as having voluntarily abandoned the services of the Organization.

Your services are liable to be terminated at any time:

- during probation or after confirmation, in case you are found to be medically unfit by the Organization's Authorized Medical practitioner, on examination;

You shall not utilize them for your own use or disclose to other persons during or after your employment.
