7.2 You may terminate your employment with the COLLEGE, without any cause, by giving no less than 2 months' prior notice or salary for unsaved period.

7.3 The COLLEGE reserves the right to terminate your employment summarily without any notice period or termination payment, if it has reasonable ground to

believe you are guilty of misconduct or negligence, or have committed any fundamental breach of contract or caused any loss to the COLLEGE.

7.4 On the termination of your employment for whatever reason, you will return to the COLLEGE all property; documents and paper, both original and copies thereof, including any samples, literature, contracts, records, lists, drawings, blueprints, letters, notes, data and the like; and Confidential Information, in your possession or under your control relating to your employment or to clients' business affairs.

## 8 Applicability of COLLEGE Policy

The COLLEGE shall be entitled to make policy declarations from time to time pertaining to matters like leave entitlement, maternity leave, employees' benefits, working hours, transfer policies etc., and may alter the same from time to time at its sole discretion. Your employment with the COLLEGE is subject to Indian laws. All disputes shall be subject to the jurisdiction of High Court Uttar Pradesh only.


