All India Council of Technical Education, New Delhi / Pharmacy Council of India, New Delhi for the academic session 2021-22 after the approval of diploma level technical educational institutions for grant of affiliation / affiliation extension to Technical Education Council, Uttar Pradesh Lucknow. On date- 08/08/2021 , the meeting of the affiliation committee was completed in the council office. In the meeting, the committee decided to grant affiliation/affiliation extension for the session 2021-22, considering other items including affiliation to the new institutions applied for for the session 2021-22 / affiliation extension to the already operating institutions / course / admission capacity increase. Went.

In continuation of the decision taken in the meeting of the affiliation committee, the following institution is given affiliation extension for the course and admission capacity mentioned in it for the session 2021-22 by Technical Education Council, Uttar Pradesh Lucknow under the following conditions:-

Conditions for Affiliation

- ✓ The institution will fully comply with all the conditions laid down by AICTE / PCI.
- ✓ The institution will comply with the Uttar Pradesh Technical Education Council Act 1962 and Technical Education Council Regulations 1992, Semester Regulations-2016 and other made rules and orders and the fee prescribed by the Fee Fixation Committee is Rs.30150.00/- per annum for three-year engineering courses, two-year pharmacy courses. For Rs. 45000.00/- per annum and for one- and two-year courses (in addition to two-year pharmacy course), only Rs.-22500.00/- per annum fee will be collected from each student. In addition to the above, the government orders issued by the government from time to time regarding fees from students will be effective. And action will be required to be taken accordingly. If the fees for the session 2021-22 are rescheduled by the Fee Fixation Committee, then the latest rates of fees will be applicable.
- ✓ The institution has to comply with the conditions of (U.P. Technical Education Committees and Sub-Committees, Associations to be Affiliated) Regulations-2000.
- ✓ Admission will be given only to the students allotted by the Joint Entrance Examination Council in the institution. In case the seats remain vacant, the admission process will be done as per the instructions of the Uttar Pradesh government.
- ✓ The institution will have to pay inspection and affiliation fee as per the mandate issued from time to time.
- ✓ It will be necessary for the institution to get approval from AICTE/PCI for the upcoming session.
- ✓ The institution is to follow the laws/rules/acts/orders/instructions made by the Government of Uttar Pradesh and the rules, regulations, orders, directions made by the Director, Technical Education, Uttar Pradesh, Joint Entrance Examination Council, Uttar Pradesh and Council of Technical Education, Uttar Pradesh. Will be obliged

- ✓ Institutions of Diploma in Pharmacy course if PCI. If it fails to get approval from New Delhi, then the entire responsibility in this regard will be with the institution and the institution itself will be responsible for any action taken legally. A suit is filed with the Council of Technical Education, Joint Entrance Examination Council, Directorate of Technical Education and Department of Technical Education, Government of Uttar Pradesh and regarding the suit filed, Mr. If any kind of reimbursement order is issued by the court, then all the reimbursement will have to be done by the concerned institution.
- ✓ Institutions conducting Diploma in Pharmacy courses will have to obtain approval from PCI and make available to the Council office before the start of counseling for the entrance examination conducted by Joint Entrance Examination Council, Uttar Pradesh Lucknow for every year, otherwise they will have to get admission (through counseling). or direct entry at institution level) will not be allowed.
- ✓ It will be necessary to follow the latest reservation rules issued by the Uttar Pradesh government for admission.
- ✓ The institution will have to provide all the information of the institution on its website such as the details of the institution's historical background, staff, furnishings, equipment, fee to be received, hostel fee etc.
- ✓ Along with providing the above environment for teaching-training, the institution will have to ensure all necessary arrangements regarding the prevention of ragging.
- ✓ The institution should ensure that the records, land-building, furniture, equipment, etc., made available before the inspection committee for running the proposed / conducted course in the institution, are used by the institution in the conduct of any other course and the council If it is known that the organization is using the above for any other work, then it will be recommended to discontinue the affiliation of the institution immediately.
- ✓ During the site inspection of the institution, if the land, building, laboratory, equipment and other furnishings in the institution are not found available as per the standards of AICTE/PCI/Council, then the association of the organization will be terminated.
- ✓ In case of non-compliance of affiliation conditions or violation of conditions, disciplinary action will be taken as per rules.
