" The Bachelor of Pharmacy (B.Pharm) Course Regulations, 2014 In view of above, it was decided to instruct the institution not to make admission from 2022-2023 academic session in 1st year in B.Pharm course. Further 381/EC(11.11.2022) decided as under- it was decided to grant approval for 2022- 2023 academic session with approved intake of 2021-2022 academic session further notifying the said institutions:- a) to submit the prescribed affidavit along with institute s information (enclosed as Annexure-A) and upload the faculty database within one month of receipt of Council s decision. b) affidavit should be uploaded on institution s dash board on the portal of Pharmacy Council of India, New Delhi within one month of receipt of this decision without fail. There should not be any change / modification / alteration in the affidavit. In case any change is observed, the same will not be entertained at any cost and the liabilities will rest only with the Institute and NOT PCI. ' c) the above decision is subject to verification of compliance by the PCI at any later date and if compliance is found false, PCI will initiate action for withdrawal of approval u/s 13(1) of the Pharmacy Act, 1948 and consequences thereof and responsibility will rest on the institution alone. 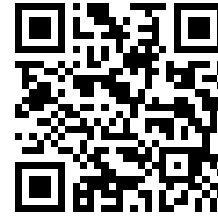
